



RELEASE AND INDEMNIFICATION

THIS RELEASE is executed on _____ (date), by _____, of _____ (address), City of _____ County of _____, State of Ohio, referred to as releasor.

In consideration of access to participate in horse riding activities and to use the equestrian facilities and/or the premises known as the Lake Erie College Equestrian Center releasor, for _____ (himself or herself) and _____ (his or her) personal representatives, executors, administrators, heirs and next of kin, releases, waives, discharges and covenants not to sue Lake Erie College and/or its trustees, officers, members, employees and each of them, all referred to as releasees, from all liability to the releasor, _____ (his or her) personal representatives, executors, administrators, heirs and next of kin for all loss or damage, any claim or damage, on account of injury to the person or property or resulting in death of the releasor, whether caused by the negligence of releasees or otherwise while the releasor is participating in horse riding activities and the use of the equestrian facilities and/or the premises known as the Lake Erie College Equestrian Center.

Releasor agrees to indemnify the releasees and each of them from any loss, liability, damage or cost releasees may incur due to the presence of the releasor while in or participating in horse riding activities and to use the equestrian facilities and/or the premises known as the Lake Erie College Equestrian Center whether caused by the negligence of the releasees or otherwise.

Releasor assumes full responsibility for and risk of bodily injury, death or property damage due to negligence of releasees or otherwise while in or participating in horse riding activities and to use the premises known as the Lake Erie College Equestrian Center and/or for any other risk while participating in horse riding activities or to use the equestrian facilities and/or the premises known as the Lake Erie College Equestrian Center.

Releasor agrees that this release, waiver and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Ohio and that if any portion of the agreement is held invalid, it is agreed that the balance will, notwithstanding, continue in full legal force and effect.

Releasor, being of lawful age, in consideration of being permitted to participate in horse riding activities and to use the equestrian facilities and/or the premises known as the Lake Erie College Equestrian Center does for _____ (himself or herself), _____ (his or her) heirs, executors, administrators, personal representative and next of kin, release and forever discharge Lake Erie College, its trustees, officers, members and employees and each of them, their successors and assigns, heirs, executors, administrators, personal representatives and next of kin, of and from any and every claim, demand, action or right of action, of whatever kind or nature, either in law or in equity arising from or by reason of any bodily injury or personal injuries known or unknown, death and/or property damage resulting from participation in horse riding activities and to use of the equestrian facilities and/or the premises known as the Lake Erie College Equestrian Center from any accident which may occur as a result of releasor's participation in horse riding activities and to use the equestrian facilities and/or the premises known as the Lake Erie College Equestrian Center or any and all activities by releasor in connection with participation in horse riding activities and to use the equestrian facilities and/or the premises known as the Lake Erie College Equestrian Center whether by negligence or not.

Releasor further states that ____ (*he or she*) has carefully read the above release and knows the contents of the release and signs this release as ____ (*his or her*) own free act.

Releasor further releases all first aid officials and professional personnel from any claim whatsoever on account of first aid, treatment or service rendered ____ (*him or her*) during participation in horse riding activities and to use the equestrian facilities and/or the premises known as the Lake Erie College Equestrian Center.
