# Appendix 1: Sampling and recruitment

This appendix provides detail of the sample sought and achieved for the summit. It also includes the invitation sent to participants.

## Achieved sample

The table below shows the number of attendees for each of the sessions that were invited and attended against the original target quotas. In total, 75 participants took part in the research (71 participants took part in the first workshop, and this grew to 75 in part following the recruitment of participants to a condensed form of participation across two sessions). Of these, 58 participants attended all four workshops and 66 attended the final workshop.

The target quotas in the table below are based on the original target sample size of 100 participants. In the end 85 were invited to the first workshop and 75 participated in at least one workshop. All these participants had experience of the housing emergency and met socioeconomic sampling criteria (majority C2DE). The achieved sample included participants from across the country, although South West residents were under-represented. The reduced sample size also meant the following characteristics had reduced representation than initially planned:

- People identifying as male, people identifying as trans/non-binary/other or who preferred not to state their gender identity.
- Gay and lesbian participants.
- Bangladeshi, White Other, Black African, and Black Carribean participants.
- Participants from a rural location.
- Participants living with a partner and children, or participants living with a partner but without children.
- Participants who stated they had experienced discrimination relating to their housing situation.
