### Introduction

Shelter has conducted new research to create a national picture of England's repossession hotspots. These hotspots are identified as areas with the highest proportion of private homes on which repossession claims have been issued by mortgage lenders. The issuing of a mortgage possession claim is the first step in a process which can result in a homeowner losing their home thus all the households receiving these claims can be described as 'at risk'.

Shelter is publishing these findings to highlight the risks faced by homeowners in the current climate, risks which are likely to rise if interest rates and unemployment rise, and to encourage homeowners who may be in difficulty to seek advice early before their problems get out of hand. We hope this research will be useful for anyone providing advice or housing services, to help them plan ahead and anticipate the support their clients may need.

The results in this report are based on 12 months of data for the financial year 2011/12 to provide an accurate picture of those at risk. This research is not directly comparable with the Repossession Hotspots report published in the summer of 2011, as it uses possession claims rather than possession orders as its metric. This change has been made in order to provide earlier indications of the emerging trends, so that local authorities and individuals can take action earlier, and to align the work with other projects carried out by Shelter, notably the Eviction Risk Monitor report published in December 2011.

#### Method

This analysis was carried out using the Ministry of Justice statistics on possession claims issued by mortgage lenders, published in April 2012<sup>1</sup>. These figures cover the financial year 2011/12.

A rate of possession claims issued per 1,000 private homes<sup>2</sup> was calculated for each local authority in England<sup>3</sup>, using the latest available data on the number of private homes published by the Department for Communities and Local Government (DCLG)<sup>4</sup>.

Local authorities were then ranked by their rate of claims issued per 1,000 private homes and split into five equally sized groups (quintiles).

The tables and colour-coded maps in this report show the results of this analysis for each local authority, nationally and by region.

Local authority unemployment rates<sup>5</sup> at September 2011 and trends between September 2008 and September 2011 were also analysed against the five possession claim rate groups to explore links between rates of possession claims and unemployment.

Social rented and publicly owned dwellings were removed as they are not subject to the same type of possession claims. The private rented sector is included as, if mortgaged, these homes may be repossessed in the same way as owner-occupied homes.

## **Key Findings**


- Rates of possession claims issued vary widely across the country the highest rate (in Barking and Dagenham, 8.44 per 1,000) is almost eight times the lowest rate (West Dorset, 1.06 per 1,000).


Figure 4: Table of number and rates of possession claims issued, regional overview

- Average rates of possession claims by region appear to show a pattern, with the highest rates of claims in the northern regions of England, and the lowest rates in the south (see Figure 4).
- However, this overall pattern masks a wide variation within regions; this is most pronounced in London, where the rate of possession claims in Barking and Dagenham (the highest in England at 8.44 per 1,000) is nearly six and a half times that in Kensington and Chelsea (1.3 per 1,000).
- Mapping the results (see Figure 1) shows clustering of those local authorities with the highest rates of possession claims in the following areas:
  - o Durham and Tyneside
  - A 'red band' stretching almost unbroken across northern England, from the Mersey to the Humber, with a spike extending south into Derbyshire
  - The West Midlands conurbation
  - Central England (Northampton, Wellingborough and Milton Keynes)
  - The Wash (South Holland, Peterborough, Fenland)
  - East London and the Thames Estuary.
- Higher rates of possession claims are strongly associated with higher and increasing rates of unemployment (see Figure 3):
  - The average rate of unemployment in the local authorities with the highest rates of possession claims is 10.4%, compared with 5.5% for those with the lowest rates of possession claims<sup>6</sup>.
  - On average, unemployment has risen by 3.1 percentage points in the local authorities with the highest rates of possession claims, compared with a rise of 1.9 percentage points in those with the lowest rates of possession claims<sup>7</sup>.

## Headline results

This section provides figures for the highest and lowest quintiles, and shows an association between possession claim rates and unemployment rates and trends. The dividing lines on Figure 2 show where the highest and lowest quintiles are situated – local authorities (LAs) within the highest quintile (the highest 65) are described as hotspots. For a full list of all LAs, see Figure 23.

Figure 3 above shows that the current rate of unemployment in the LAs with the highest fifth of possession claim rates is 10.4%, compared to a rate of 5.5% in the LAs with the lowest fifth of possession claim rates. Unemployment is also increasing at a higher rate in authorities with a higher rate of possession claims.

There are two main ways of measuring unemployment; the table above uses the Labour Force Survey, which asks respondents if they have actively sought work in the last four weeks. Analysis using the other main measure of unemployment - Jobseekers Allowance claimant counts, shows a similar pattern with higher rates in the LAs with the highest rates of possession claims.



## Regional results

This section shows the results of the analysis at a regional level, displaying a map and a table for each region. The hotspots in each region are identified on the relevant map, and the same colour scheme is used on the maps and the tables.




Figure 7: Table of number and rates of possession claims issued, 2011/12, North West region table




Figure 11: Table of number and rates of possession claims issued, 2011/12, East Midlands region table

Figure 16: Rates of possession claims issued, 2011/12, East of England region map




Figure 17: Table of number and rates of possession claims issued, 2011/12, London region table





Figure 18: Rates of possession claims issued, 2011/12, London region map





Figure 20: Rates of possession claims issued, 2011/12, South East region map




