## CLEANSING NOTICE

### NOTIFICATION PURSUANT TO SECTION 708A(5)(e) OF THE CORPORATIONS ACT 2001 ("Act")

On 2 September 2019, Myanmar Metals Limited (ASX: MYL) (the "Company") issued 400,000 ordinary shares ("Shares") in the capital of the Company upon the conversion of listed options.

MYL intends to become a leading regional base metals producer and is well positioned to realise this goal, based on the Tier 1 Bawdwin project resources, world class exploration potential, strategically advantageous project location, management team with experience and depth, highly capable local partners and a strong balance sheet with supportive institutional shareholders.
