

UPDATED: Diverse Coalition of Stakeholders to Hold Media Briefing on IRS Service Issues

Washington, D.C. (January 24, 2022) – The Tax Professionals United for Taxpayer Relief Coalition is holding a virtual media briefing on Tuesday, January 25, 2022, to discuss IRS (Internal Revenue Service) service issues that have caused unnecessary stress and anxiety for taxpayers throughout the COVID-19 pandemic.

The Tax Professionals United for Taxpayer Relief Coalition is comprised of American Institute of CPAs (AICPA), together with Latino Tax Pros, National Association of Black Accountants, Inc.
