#### AWM is a complete Business Process

Management (BPM) system that will help you increase your operational efficiency. Flexible and customizable, the solution automates your internal workflows to assist you in your daily tasks. This agnostic system can be configured internally to enhance workflows, alerts and access management.

#### Workflow chain

The solution allows companies to fully replicate their internal organisations and associate their teams and/or departments to dedicated workspaces combining two elements:

- The dedicated systems that users operate in their day-to day work (ex. relationship managers will operate CRM and reporting softwares);
- The related tasks and alerts.

Each system, task and alert can be defined for each workplace -and its related users- and


automatically programmed through the AWM solution. It allows a complete flexibility and a full automation of processes (cf Central Management organization below).

# Centralized access point & integration

The FNZ' AWM solution is an agnostic system that can be connected to any third party application. It is natively integrated with the FNZ solutions (APSYS, Banker's Front, Logical Access) and can provide out of the box workflows, such as restriction breach management, corporate actions, reporting, etc.

It is a centralized access point from which the users will:


- Access all the applications used for their day-to-day work,


