Executive Summary

An initial institutional visit to GBIF-Spain was conducted, With a focus on training with regards to the eLearning Platform, as well as having discussions with regards to data use and data analysis, as well as discussions related to data science aspects like, big data and Artificial intelligence. A draft agenda including topics and potential trainers was put together for the training workshop that will be held in South Africa in June 2023. A course was created on the eLearning platform with 30% of the content uploaded.

An additional data science expert, Dr Dr. Fernando Aguilar, will be joining the in-person training in South Africa to bring relevant skills to the training event. An additional expert from GBIF Spain might also assist with writing scripts and material although will not attend as a trainer. An additional member of staff from SANBI, Mrs. Hannelie Snyman, also attended the first meeting.

Report on Activities

Activity progress summary

Activities 1 and 2 were carried out in December 2022 in Spain. Activity 1 was 100% complete, and a course was created on the eLearning platform for the training workshop in July 2023. The eLearning training and information exchange allowed for SANBI-GBIF support person to gain new insights on the online platform which included various methods enhance efficiencies in data and information upload, to decrease the in the amount of time it takes to create and upload content to the online course. Together with GBIF-SPAIN support staff, the course was created with documents and information being uploaded immediately. There was a delay in when this trip was taken (December instead of August) due to COVID regulations, which limits the amount of time available for the overall project to be undertaken. A movement in travel dates meant an increase the cost of flight tickets. Activity 2 was successful with 80% completion. Discussions and engagements on the identification of data techniques and analyses to support impactful data use cases/stories were conducted. Lists of topics, techniques, and trainers were established, which allowed for the generation of an agenda for the training in June 2023, in South Africa. The remaining 20% will be finalized in activity 3- the institutional visit to SA in March 2023.

Activities 3 and 4 will take place a month later than originally identified in the proposal, however, this will not impact the project negatively, as it still falls within the project period.
