Important Questions	Answers	Why This Matters:
What is the overall deductible?	\$1,400/individual or \$2,800/family	Generally, you must pay all of the costs from providers up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your deductible?	Yes. Preventive care, office visits, outpatient services, medical supplies, and most home health services.	This <u>plan_covers</u> some items and services even if you haven't yet met the <u>deductible_amount</u> . But a <u>copayment</u> or <u>coinsurance</u> may apply. For example, this <u>plan_covers</u> certain <u>preventative services</u> without <u>cost sharing_and before you meet your <u>deductible</u>. Are there other deductibles for specific services?	Yes. \$100/individual or \$200/family for Tier 2,3 and 4 prescription drugs. There are no other specific deductibles.	You must pay all of the costs for these services up to the specific <u>deductible</u> amount before this <u>plan</u> begins to pay for these services.
What is the <u>out-of-pocket</u> <u>limit</u> for this <u>plan</u> ?	\$2,700 individual / \$5,400 family	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. If you have other family members in this <u>plan</u> , they have to meet their own <u>out-of-pocket limits</u> until the overall family <u>out-of-pocket limit</u> has been met.
What is not included in the <u>out-of-pocket limit</u> ?	Premium, balance billing charges, and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit.
Will you pay less if you use a <u>network provider</u> ?	Yes. See https://cchphealthplan.com/family-membe r or call 1-888-775- 7888 for a list of network providers .	This <u>plan</u> uses a <u>provider_network</u> . You will pay less if you use a <u>provider_in</u> the plan's <u>network</u> . You will pay the most if you use an <u>out-of-network provider</u> , and you might receive a bill from a <u>provider_for_the difference between the provider</u> 's charge and what your <u>plan</u> pays <u>(balance billing)</u> . Do you need a <u>referral</u> to see a <u>specialist</u> ?	Yes.	This <u>plan</u> will pay some or all of the costs to see a <u>specialist</u> for covered services but only if you have a <u>referral</u> before you see the <u>specialist</u> .

Does this plan provide Minimum Essential Coverage? Yes

If your plan doesn't meet the Minimum Value Standards, you may be eligible for a premium tax credit to help you pay for a plan through the Marketplace.
