

TERMS AND CONDITIONS FOR WESTFIELD “MOTHER’S DAY GIFT CARD - GIFT WITH PURCHASE 2018” PROMOTION

1. Information on how to claim this gift with purchase forms part of these Terms and Conditions. Participation in this “Mother’s Day Gift Card - Gift with Purchase 2018” Promotion (“Promotion”) is deemed acceptance of these Terms and Conditions.

PROMOTER DETAILS

2. Scentre (New Zealand) Limited (“Promoter”) is the promoter of this Promotion and its registered office is located at Level 2, Office Tower, 277 Broadway, Newmarket, Auckland.

WHO CAN PARTICIPATE

3. The promotion is open to those aged 18 years or over. The following are ineligible: (i) employees of the Promoter or Scentre Group or any of the Promoter’s agencies or suppliers that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of any excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.

PROMOTION PERIOD

4. This Promotion commences at 9.00am on Monday 07/05/2018 and ends at midnight on Sunday 13/05/2018 or WHILE THE NUMBER OF GIFTS LASTS, whichever occurs first (“Promotion Period”).

GIFT

HOW TO OBTAIN THE GIFT

8. The Promotion will be conducted at the following four (4) Westfield New Zealand Shopping Centres: Westfield Albany, Westfield Manukau City, Westfield Riccarton, Westfield St Lukes, (“Participating Centres”).

GENERAL

15. The Promoter will not be liable for any prizes that are lost, stolen or damaged and will not replace them.

The Promoter reserves the right in its sole discretion to disqualify any entrant who tampers with the entry process.

The Promoter and any Suppliers associated with this Promotion will not be liable for any damage or loss (including but not limited to indirect or consequential loss) arising from personal injury or death or loss, or damage to property which is suffered or sustained in connection with any prize, except to the extent that liability cannot be excluded by law. 20. These terms and conditions shall be governed by and construed in accordance with the laws of New Zealand and shall be subject to the exclusive jurisdiction of New Zealand Courts.
