



Getting started

IMPORTANT


Do not place your CT100 in the bathroom or other humid areas.

Location

You need to place your CT100 base within 1.5 metres of the telephone wall socket so that the cable will reach. The socket-outlet should be installed near the equipment and should be easily accessible.

If you are wall mounting your phone please refer to the wall mount template over the page.


Connecting the handset and base



1. Plug one end of the handset curly cord into the socket marked on the underside of the base and the other end into the socket at the bottom of the handset.
2. Plug the telephone line cord into the socket marked .

Getting started


Overview of your handset



- A Earpiece**
To listen to your caller.
- B Microphone**
To speak to your caller.
- C Curly cord socket**
Where you plug in your curly cord.

Getting started

Overview of the base



- A Hook switch**
Hangs up a call when pressed or when you replace the handset.
- B Mute**
Speak to someone nearby without your caller hearing the conversation.
- C R**
Recall used with switchboards / PABX.
- D Redial**
Press to redial the last number called.
- E Pause**
Press to enter a pause (P) when dialling numbers.
- F Ringer switch**
Change the ringer volume.

Using the phone

3.1 Calls

3.1.1 Make a call

Lift the handset, when you hear the dial tone, dial the number.

3.1.2 End a call

Place the handset back on the base.

3.1.3 Receive a call

Lift the handset to answer the call.

3.2 Mute

You can mute your handset so that you can talk to someone nearby without your caller hearing.

1. During a call, press and hold .
2. Release again to resume your call.

3.3 Redial

The last entry dialled is stored in the phone; the number can be up to 31 digits long.

To redial the last entry called, pick up the handset and press .

3.4 Ringer volume control

Switch the ringer volume between high (left) normal (middle) and low (right).

3.5 Recall

Recall is useful to access certain network services and PABX / switchboard services.

For more information about network services contact your network operator.

The recall mode preset in the CT100 is suitable for your country network.

Help

No dial tone

- Use only the telephone line cord supplied.
- Check that the telephone line cord is connected properly.

IMPORTANT

This product is intended for connection to analogue public switched telephone networks and private switchboards in India.

Important safety instructions

Cleaning

- Clean the handset and base with a damp (not wet) cloth, or an anti-static wipe.
- Never use household polish as this will damage the product. Never use a dry cloth as this may cause static shock.

- Do not place your product on carpets or other surfaces which generate fibres, or place it in locations preventing the free flow of air over its surfaces.

Technical Information

How many telephones can I have?

All items of telephone equipment have a Ringer Equivalence Number (REN), which is used to calculate the number of items which may be connected to any one telephone line. Your CT100 has a REN of 1. A total REN of 4 is allowed. If the total REN of 4 is exceeded, the telephones may not ring. With different telephone types, there is no guarantee of ringing, even when the REN is less than 4.

Connecting to a switchboard

This product is intended for use within India for connection to the public telephone network.

Recall


You may need to use the recall function if you are connected to a switchboard. Contact your PABX supplier for further information.

Wall mounting

IMPORTANT

Before you wall-mount your CT1, check that you are not drilling into any hidden wiring or pipes. Before you drill, make sure the telephone line cable will reach the socket.

1. Drill two holes in the wall 10cm apart vertically using an 8mm drill bit.
