illimity Group



illimity Bank S.p.A. (“illimity”) is the parent company of the Group of the same name. Everything began in January 2018 when SPAXS S.p.A. (“SPAXS”) was launched, becoming the largest Italian Special Purpose Acquisition Company and one of the biggest in Europe. The focus was to acquire and capitalise a company in the banking industry, with €600 million raised.

The purchase of Banca Interprovinciale S.p.A. (“Banca Interprovinciale”) in 2018 and the merger with SPAXS formed the basis for the creation of illimity Bank, which since the 5th of March 2019 is listed on the Italia Stocj Exchange’s MTA equities market and since the 10th of September 2020 on the STAR segment.

illimity is a new paradigm bank that specialises in lending to SMEs, using a truly innovative and highly technological business model. illimity lends to companies that have real potential, with low or no ratings, even if they are in the non-performing SME segment (Unlikely-To-Pay). illimity also acquires secured and unsecured distressed corporate credits, to then service these using its neprix platform. It offers innovative direct digital banking services for retail and corporate customers through its own direct digital bank, illimitybank.com, that in September 2020 announced a new joint venture with Fabrick (Sella Group) in the Fintech HYPE. Also, through illimity SGR sets up and manages Alternative Investment Funds, the first of which is dedicated to UTP credits.



As of June 2021, the illimity Group consists of the following companies:

neprix S.r.l. (“neprix”), which was launched in April 2019 and specialises in servicing distressed corporate credits using a multi-disciplinary, technological and innovative servicing model. The purchase of IT Auction S.r.l., in March 2020, a market leader in managing online auctions for real estate and business assets, has turned neprix into the leading end-to-end servicer in the distressed corporate credit industry, making a difference across the entire value chain.

illimity SGR S.p.A. (“illimity SGR”) is the asset management company in the illimity Group, founded to create and manage alternative investment funds that predominantly focus on corporate lending.

It received authorisation from the Bank of Italy in February 2020.

The Group also includes a series of special purpose vehicles, for securitisation transactions, used to acquire distressed credit portfolios.

Inauguration of illimity's innovative new company offices, with smart spaces, in Palazzo Aporti in Milan.

March 2019

On 5 March, illimity Bank S.p.A. is born, with its listing on Borsa Italiana's MTA market

April 2019

Presentation by illimity of neprix, the servicer specialising in the servicing of distressed corporate credits

June 2019

illimity signs an agreement to purchase IT Auction. Together with neprix, this marks the creation of the first end-to-end servicer specialising in distressed corporate credits

September 2019

Launch of illimitybank.com, the third core of illimity, providing direct digital banking services for retail and corporate customers

February 2020

Birth of illimity SGR to create and manage alternative investment funds

September 2020

illimity ordinary shares admitted for trading on the Star segment of the Italian Stock Exchange

Announcement of the Joint Venture illimity – Fabrick (Sella Group) in the Fintech HYPE

December 2020

illimity successfully completes its first bond issue

March 2021

illimity is appointed as Nomad for Italy's Alternative Investment Market

illimity Credit & Corporate Turnaround, the first fund of illimity SGR, is established.

The purchase of IT Auction further bolstered our business model as it is a leader in online auctions for real estate and business assets.

Operational since 12 September 2019, it offers customers a complete range of banking services and products using a latest-generation platform that combines specialist expertise with cutting-edge technology. Designed with customers and for customers, illimitybank.com is an innovative bank with a complete offer that covers current and savings accounts, the latest payment systems - including the ability to make payments from multiple banks using a single app -, expenditure monitoring, and an entire ecosystem of excellent partnerships, also beyond the banking field.
