#### **COMPANY PROFILE**

ACCENTRO Real Estate AG is a residential property investor and Germany's market leader in housing privatisations. Its real estate portfolio consisted of around 5,200 units as of 31December 2020. In addition to Berlin, regional focal points include East German cities and conurbations, as well as the Rhine-Ruhr metro region and Bavaria. The business activity of ACCENTRO comprises four core divisions: the tenant-sensitive retailing of condominiums to private owner-occupiers and buy-to-let investors, the sale of real estate portfolios to institutional investors, the set-up management of a proprietary real estate portfolio, and third-party condominium marketing for property asset holders, investors and developers.

### HIGHLIGHTS OF FINANCIAL YEAR 2020

- German residential property market proves highly resilient during COVID pandemic
- Sales volume in privatization business (EUR 119m) exceeds prior-year level
- Property portfolio more than doubled to around 5,200 units; significant expansion of proprietary holdings
- Continued regional portfolio diversification with focus on fast-growing regions in East Germany and the Rhine-Ruhr metro region

- Group EBIT before one-off expenses reaches new record level at EUR 40.8 million
- Growth significantly increases total assets to EUR 862m
- Hidden reserves (EUR 135m) of inventory properties and gain on fair value adjustment (EUR 28m) of the investment properties indicate appreciation potential of portfolio
- Forecast for 2021: increase in Group revenues (EUR 170-200m) and Group EBIT (EUR 45-50m) well into the double-digit range
- Existing privatisation portfolio of already lawfully partitioned properties worth
   c. EUR 0.5bn is the basis for future growth




# SHAREHOLDER STRUCTURE (31.12.2020)




