Specifications:

The MR6 Headliner Brackets for all models fit over the vehicle's headliner and provide a signal through the windshield. For MR6 light head specifications and operation see the MR6 installation manual.

Installation and Mounting:

<u>Step-1.</u> Pry open the small cover on the sun visor retaining clip with a small flat bladed screwdriver to gain access to the sun visor retaining clip screw. Remove the single Torx screw that holds each clip in place.

<u>Step-2.</u> Remove the plastic visor clips from the headliner fabric. Thread the Torx screw back into the plastic clip just slightly for easier assembly later.

<u>Step-3.</u> (For 2015+ RAM see Note**) Making sure the light head's cable is routed through the provided knotch in the headliner bracket, Align the rectangular slot in the lower portion of the headliner bracket with the visor clip's rectangular hole in the vehicle's headliner. The bracket will be entirely visible as it is positioned over the headliner.

<u>Step-4.</u> Position the headliner and bracket back into position and reposition the visor clip through the rectangular opening in the headliner bracket and the vehicle's headliner and refasten it using the screw removed in step 2.

Step-5. Route and wire the light head wiring as desired.

NOTE** For 2015+ Dodge Ram headliner brackets: (2) Additional brackets are needed as light head must first be fastened to the additional brackets, then the additional brackets can be mounted to the headliner bracket.
