# Installation and Operation Instructions C3100 SPEAKER MOUNT - 2014+ DODGE DURANGO

# **Installation and Mounting:**

Installation of the C3100 Slim Speaker in the 2014+ Dodge Durango is much easier if the entire front bumper of the Durango is removed before the installation begins.

- Step 1. Remove vehicle components to gain access to front of the right hand side front wheel well.
- Step 2. Using the factory stud pictured in Figure 1, mount the Speaker with bracket using the washer and M8 nyloc nut provided in the kit.
- Step 3. Secure speaker and run wires as shown in Figures 3 and 4.
- Step 4. Reinstall parts removed to gain access.








