



Installation and Operation Instructions

Mounting Kit, Silverado & F150

IMPORTANT! Read all instructions before installing and using. Installer: This manual must be delivered to the end user.

1. Proper installation combined with operator training in the use, care, and maintenance of emergency warning devices are essential to ensure the safety of emergency personnel and the public.

4. Proper placement and installation is vital to the performance of this warning device. Install this product so that output performance of the system is maximized and the controls are placed within convenient reach of the operator so that they can operate the system without losing eye contact with the roadway.
5. Do not install this product or route any wires in the deployment area of an air bag. Equipment mounted or located in an air bag deployment area may reduce the effectiveness of the air bag or become a projectile that could cause serious personal injury or death. Refer to the vehicle owner's manual for the air bag deployment area. It is the responsibility of the user/operator to determine a suitable mounting location ensuring the safety of all passengers inside the vehicle particularly avoiding areas of potential head impact.
6. It is the responsibility of the vehicle operator to ensure daily that all features of this product work correctly. Installation and Mounting - Chevy Silverado 2019+

1. Lower headliner according to factory manual
2. Insert backing bracket into place. See Figure 1.
3. Install mounting brackets onto backing bracket.
4. Reinstall headliner according to factory manual. **Note: If planning to run wire harness through the headliner, be sure to route before reinstalling.**
5. Install Mega Thin Stik to mounting brackets using screws provided in the mounting kit. See Figure 2.

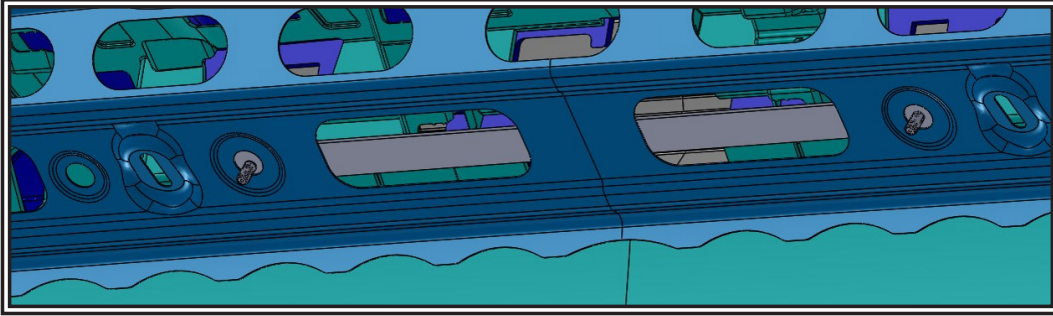

Installation and Mounting - Ford F150

1. Remove third brake light.
2. Insert backing plate into each slot. See Figure 3.
3. Lower headliner according to factory manual.
4. Install mounting brackets onto studs. See Figure 4.
5. Reinstall headliner according to factory manual. **Note: if planning to run wire harness through the headliner, be sure to route before reinstalling.**
6. Install Mega Thin Stik to mounting brackets using screws provided in the mounting kit. See Figure 5.
