

IECODE 3 Installation and Operation Instructions **2020 PIU HEADLINER**

IMPORTANT! Read all instructions before installing and using. Installer: This manual must be delivered to the end user.



Failure to install or use this product according to manufacturer's recommendations may result in property damage, serious injury, and/ or death to those you are seeking to protect!

Do not install and/or operate this safety product unless you have read and understood the safety information contained in this manual.

- Proper installation combined with operator training in the use, care, and maintenance of emergency warning devices are essential to ensure the safety of emergency personnel and the public.

- This product must be properly grounded. Inadequate grounding and/or shorting of electrical connections can cause high current arcing, which can cause personal injury and/or severe vehicle damage, including fire.
- Proper placement and installation is vital to the performance of this warning device. Install this product so that output performance of the system is maximized and the controls are placed within convenient reach of the operator so that they can operate the system without losing eye contact with the roadway.

Installation and Mounting:

- **Step 1.** Remove the plastic covers from the outer sun visor pivot brackets (see Figure 1). Remove the screws from the pivot bracket and discard the screws. Pull the visor pivot brackets down from the headliner and carefully allow the sun visors to hang by the vehicle's vanity mirror light wires.
- **Step 2.** Remove the plastic visor clips by removing the single Torx screw holding each clip in place as shown in Figure 2 on and discard the screws.
- **Step 3.** Mount the desired MR6 light engines to the headliner bracket using provided hardware.
- **Step 4.** Position the headliner bracket against the vehicle's headliner. Reposition the plastic outer visor pivot brackets over the bracket and fasten into position provided #8 X 1" Phillips Truss Head Black Oxide Screws as shown in Figure 3. Reattach plastic covers removed in Step 1 as shown in Figure 4.
- **Step 5.** Position the inner visor clip brackets through the headliner bracket and position them up to the headliner. Thread the supplied #8 X 1" Phillips Truss Head Black Oxide Screw through the vehicle's plastic inner visor clip and into the screw hole in the vehicle's headliner (See Figure 5).
