

2018 – 2019 CONSISTENCY CLUB AUSTRALIA AND NEW ZEALAND PROGRAM OFFICIAL RULES

The Consistency Club Program (“Program”) was designed to promote overall business balance between selling and enrolling new US or CA Customers and new US or CA Ambassadors. By focusing on both selling and enrolling consistently you will build a strong foundation and a lasting business.

The Consistency Club Program is open to all Ambassadors residing in the Australia and New Zealand. Employees of Plexus Worldwide, LLC (the “Company” or “Plexus”) and its respective subsidiaries, affiliates, and agents, as well as the immediate family (spouse, parents, siblings and children) and household members of each such person are not eligible. The Program is subject to all applicable federal, state, and local laws and regulations and is void where prohibited by law. Program participants are referred to as “you” or “your.”

The Program period begins on July 1, 2018, 12:00 a.m. (ET) through March 31, 2019, 11:59 p.m. (ET) (the “Contest Period”). The Contest Period will be split into three contest periods: Contest Period 1 (July 1, 2018 through September 30, 2018; Contest Period 2 (October 1, 2018 through December 31, 2018); and Contest Period 3 (January 1, 2019 through March 31, 2019) (collectively referred to as the “Contest Periods”). To be eligible for this Program, Ambassadors must be in “Good Standing” in accordance with Plexus’ Ambassador Agreement and Policies and Procedures throughout the Contest Period. “Good Standing” shall be defined to mean the following:

- i) You have acknowledged and agreed to the Ambassador Agreement (and any addendums thereto) and the Company’s Policies and Procedures; and
- ii) You are not in violation of the Company’s Terms and Conditions and Policies and Procedures.

Eligibility for CLUB 300 is based on: 1) Enrolling/Personally Sponsoring a brand new US or CA Ambassador with a Welcome Pack purchase within their first 30 days. A “brand new” Ambassador is defined as a person who has never been a Plexus Ambassador; 2) Enrolling/Personally Sponsoring a brand new Preferred and/or Retail US or CA Customer with a minimum 75 Personal Volume (“PV”) initial order or more; and 3) maintaining a minimum of 300 Personal Volume (“PV”) during the current qualifying calendar month (PV may come from one or a combination of your own PV, Retail Customers and/or your Preferred Customers).

Eligibility for CLUB 500 is based on: 1) Enrolling/Personally Sponsoring two brand new US or CA Ambassadors with a Welcome Pack purchase within their first 30 days. A “brand new” Ambassador is defined as a person who has never been a Plexus Ambassador; 2) Enrolling/Personally Sponsoring two brand new Preferred and/or Retail US or CA Customers with a minimum 75 PV initial order; and 3) maintaining a minimum of 500 Personal Volume (“PV”) more than 500 PV during the current qualifying calendar month (PV may come from one or a combination of your own PV, Retail Customers and/or your Preferred Customers).

Eligibility for CLUB 700 is based on: 1) Enrolling/Personally Sponsoring three brand new US or CA Ambassadors with a Welcome Pack purchase within their first 30 days. A “brand new” Ambassador is defined as a person who has never been a Plexus Ambassador; 2) Enrolling/Personally Sponsoring three brand new Preferred and/or Retail US or CA Customers with a minimum 75 PV initial order; and 3) maintaining a minimum of 700 Personal Volume (“PV”) more than 700 PV during the current qualifying calendar month (PV may come from one or a combination of your own PV, Retail Customers and/or your Preferred Customers).

To qualify for the Consistency Club 300, 500 or 700 Contest Period Prizes, you must maintain eligibility requirements during each of the Contest Periods.

All new Personally Sponsored Retail and/or Preferred US or CA Customers and Ambassadors will be qualified at that rank of their enrollment date during the Contest Periods. Retail and/or Preferred Customer upgrades to an Ambassador during the Contest Periods will **NOT** count towards your qualifications.

Prize Substitution is allowed by Plexus of equal or comparable value. Prize will be selected by Qualifying Ambassador during the month following achievement via electronic mail and will be received in the mail within two months of achievement. Prize must be chosen by April 26, 2019. If a Prize has not been chosen within this timeframe, winners will receive the cash value for the Prize of their choice.

In addition, a Special Recognition Award for CLUB 300 and CLUB 500 Qualifiers will be presented at the 2019 Convention. Qualifying Ambassadors who achieve CLUB 700 will receive a Special Recognition Award and Stage Recognition at the 2019 Convention. You must be registered and attend the Plexus 2019 Convention in order to receive the Special Recognition Award and must show proper identification. Ambassadors who qualify for this Special Recognition Award will be notified once the Contest Period is over.

To qualify for the Consistency Club 300, 500 or 700 Special Recognition Award, you must maintain eligibility requirements within all 3 Contest Periods (July 1, 2018 through March 31, 2019), in order to earn the Consistency Club Special Recognition Award at the 2019 Convention.

Ambassadors who achieve CLUB 300, CLUB 500 or CLUB 700 status for each Contest Period will be notified via electronic mail. After each of the Contest Periods, each qualifying CLUB 300, CLUB 500 and CLUB 700 Ambassador will be notified by electronic mail with a link to the prize earned during each Contest Period. Qualifying Ambassadors will be able to choose the prize based on the Club Level they achieved during that Contest Period. Qualifying Ambassadors must provide their name and mailing address within the allotted timeframe in the email notification. In the event of product returns and/or chargebacks after the Ambassadors are recognized, the Company reserves the right to review and adjust the awarded recognition prizes. In addition, you further affirm and represent that you have not committed any fraud, deception or manipulation by participating in this Program or in claiming any prize.

Each contest winner is responsible for all federal, state and local taxes and fees associated with prize receipt and/or use.
