

Vichai Srivaddhanaprabha Foundation - Local Schools Giveaway

Terms and Conditions

1. The promotion is open to the sixty-seven (67) Ofsted registered primary schools (including specialist and/or alternative provision) located closest to King Power Stadium, Filbert Way, Leicester LE2 7FL (each an “**Eligible Participant**”). Each Eligible Participant wishing to participate in the promotion must nominate a representative over the age of 18 to apply for a Pack (as defined below) on their behalf.
2. There is no cost to participating in the promotion. Internet access is required.
3. The promotion closes on the earlier of 23:59 (UK time) on 31 May 2025 or such time and date when all Packs (as defined below) have been validly claimed (the “**Closing Date**”). Applications for Packs submitted after the Closing Date will not be valid and the relevant applicant will not be eligible to claim a Pack.
4. Eligible Participants will be contacted by the Promoter before 17:00 (UK time) on 18 April 2025. To participate in this promotion and apply for a Pack, an Eligible Participant’s representative must complete and submit the online entry form provided by the Promoter before the Closing Date. Only one (1) entry is permitted on behalf of each Eligible Participant. Duplicate entries will not be valid.
5. The Promoter accepts no responsibility for applications not successfully completed due to a technical fault, technical malfunction, computer hardware or software failure, satellite, network or server failure of any kind.

The Promoter will confirm that each application meets the eligibility criteria set out in these terms and conditions, and reserves the right to require the representative who has submitted the application to provide proof of their identity, that they are entitled to apply on behalf of the relevant Eligible Participant and that the school they have applied on behalf of is an Eligible Participant. 7. Each “**Pack**” will include a selection of football training equipment for a primary school class (exact contents to be determined by the Promoter acting in its absolute discretion, but may include a kit bag, footballs and bibs).
8. There are sixty-seven (67) Packs available to be claimed in total.

The nominated representative for each Eligible Participant which has validly claimed a Pack will be notified by email (using the details provided in their application) before 17:00 (UK time) on 30 June 2025 of the arrangements for receiving their Pack, and must provide a valid UK postal address and phone number to claim their Pack. If the

nominated representative for the relevant Eligible Participant does not respond by email to the Promoter and/or collect their Pack from the Promoter within twenty-one (21) days of being notified by the Promoter, then their Pack will be forfeited, and the Promoter will not be obliged to issue a Pack to them.
