

## **Fixture Release Day 2025/2026 - Prize Draw**

### **Terms and Conditions**

1. The prize draw is open to all UK residents aged 18 or over, except employees of the Promoter, their families, agents or any third party directly associated with administration of the prize draw (including, without limitation, YinzCam, Inc).
2. Eligible individuals who (i) download, or already have downloaded, the official LCFC mobile application (the “**App**”), and (ii) using a unique email address, register a new LCFC.com account to login to the App or use their existing LCFC.com account to login to the App (the “**Login**”) between 09:00 (UK time) on Thursday 26 June 2025 and 17:00 (UK time) on Thursday 3 July 2025 (the “**Closing Date**”) will automatically be entered into the prize draw.
3. The prize draw is free to enter, and no purchase is necessary. Internet access is required.
4. Any entries made after the Closing Date will not be valid entries and will not be entered into the prize draw.
5. There is a limit of one (1) entry per person.
6. The download and use of the App is subject to the App’s Terms of Use (available at [www.lcfc.com/pages/en/terms-of-use](http://www.lcfc.com/pages/en/terms-of-use)).
7. If for any reason a technical interruption, fault or site failure occurs when downloading the App or completing a Login to the App, the Promoter does not take any responsibility for incomplete entries, and any incomplete entries will not be considered valid for entry into the prize draw. The Promoter accepts no responsibility for any entries which are not completed for any reason.
8. Two (2) winners (the “**Prize Winners**”) will be selected by random draw performed by a computer process on or before Thursday 10 July 2025. The Promoter will confirm that each winner meets the eligibility criteria set out in these terms and conditions. If a winner does not meet the eligibility criteria, their entry will be deemed void, their Prize will be forfeited, and the Promoter will be entitled (but not obliged) to select another winner in accordance with the process described above.
9. Each Prize Winner will win one (1) pair of two (2) general admission tickets for LCFC’s first EFL Championship home match of the 2025/2026 season at King

Power Stadium (the “**Fixture**”) (the “**Prize**”). There are two (2) prizes available. One Prize per Prize Winner.

10. The Prize Winners will be notified by email (using the details associated with their LCFC.com account) before 17:00 (UK time) on Monday 14 July 2025, with details of how to claim their Prize. The Prize may only be used by each Prize Winner and one (1) accompanying guest. The Prize Winners will need to bring photographic ID to the Fixture to prove their identity and collect the tickets which form part of the Prize. If a Prize Winner does not respond to the Promoter within seven (7) days of being notified by the Promoter, then their Prize will be forfeited, and the Promoter will be entitled (but not obliged) to select another Prize Winner in accordance with the process described above. The Promoter may require each Prize Winner to provide proof that they are eligible to enter the prize draw and/or of their identity.
11. The Prize is non-transferable, may not be exchanged for cash and is only valid for the Fixture (as detailed in condition 9). No refund shall be payable in the event a Prize Winner has purchased a 2025/2026 Season Ticket, hospitality package or other admission ticket for the Fixture. 14. The Promoter reserves the right to amend or cancel the Prize, or any item(s) forming part of the Prize, for administrative reasons without prior notice. Please note that the scheduling of the Fixture is subject to change, and should it be rescheduled to take place at a new time or date which the Prize Winner cannot attend, they should contact [ticketsinfo@lcfc.co.uk](mailto:ticketsinfo@lcfc.co.uk) as soon as they can to request a transfer to another LCFC EFL Championship home match during the 2025/2026 Season. The Promoter reserves the right to deny any transfer as detailed in the 2025/2026 Home Match Ticket Terms and Conditions found at [www.lcfc.com/terms](http://www.lcfc.com/terms).
15. The decision of the Promoter regarding any aspect of the prize draw is final and binding, and no correspondence will be entered into about it.
16. The Promoter must either publish or make available information that indicates that a valid award took place. To comply with this obligation, the Promoter will

send the surname and county of the Prize Winners and, if applicable a copy of their winning entries, to anyone who emails [competitions@lcfc.co.uk](mailto:competitions@lcfc.co.uk) within one (1) month after the Closing Date stated in condition 2. If you object to any or all of your surname, county and winning entry being published or made available, please contact the Promoter by email to [competitions@lcfc.co.uk](mailto:competitions@lcfc.co.uk). In such circumstances, the Promoter must still provide the information and winning entry to the Advertising Standards Authority on request.
