

## VS Foundation Grassroots Kit Prize Draw 2026

### Terms and Conditions

1. The prize draw is open to grassroots football teams affiliated in the U7-U11 categories to the Leicestershire & Rutland County FA for the 2026/27 season only (each an “**Eligible Participant**”). Each Eligible Participant wishing to participate in the prize draw must nominate a representative over the age of 18 to enter the prize draw on their behalf.
2. There is no additional cost to participating in the prize draw other than the standard cost of affiliating to the Leicestershire & Rutland County FA for the 2026/27 season. Internet access is required.
3. The prize draw opens on 4 April 2026 and closes at 17:00 (UK time) on 17 April 2026 (the “**Closing Date**”). Entries submitted after the Closing Date will not be valid and will not be entered into the prize draw.
4. To enter this prize draw, an Eligible Participant’s representative must successfully apply to be a member of the Participant’s Grassroots Scheme by completing and submitting the online entry form available at [VS Foundation Prize Draw Registration 2026 - Intellistack](#) before the Closing Date detailed in condition 3 above. Only one entry is permitted per Eligible Participant. Duplicate entries will not be valid and will not be included in the prize draw.
5. The Promoter accepts no responsibility for entries not successfully completed due to a technical fault, technical malfunction, computer hardware or software failure, satellite, network or server failure of any kind.
6. Sixty-eight (68) winners will be selected by random draw performed by a computer process on or before 20 April 2026. The Promoter will confirm that each winner selected meets the eligibility criteria set out in these terms and conditions, and reserves the right to require the representative who has submitted the entry to provide proof of their identity, that they are entitled to apply on behalf of the relevant Eligible Participant and that the team they have applied on behalf of is an Eligible Participant. If any winner(s) does not meet the eligibility criteria, their entry will be deemed void, their Prize will be forfeited, and the Promoter will be entitled to select another winner in accordance with the process described above.
7. Each “**Prize**” will include the following items:
  - 7.1 eleven (11) youth-sized outfield playing kits (made up of a shirt, shorts and socks only, which will be printed with a shirt number on the reverse, the VS Foundation logo on the sleeve and the club logo on the chest); and

- 7.2 one (1) youth-sized goalkeeper playing kit (made up of a shirt, shorts and socks only, which will be printed with a shirt number on the reverse, the VS Foundation logo on the sleeve and the club logo on the chest).
8. There are sixty-eight (68) Prizes available to be won in total. There is a maximum of one Prize per Eligible Participant.
9. The nominated representative for each winner will be notified by email (using the details provided in their entry) before 17:30 (UK time) on 20 April 2026 of the arrangements for receiving their Prize and must (i) complete the online order form and (ii) provide a valid email address, UK postal address and phone number to claim their Prize. At the order stage, each winner may select their preferred colours and sizes, subject to availability and there may be delays in delivery if there are shortages of kit available in the selected preferences. If the nominated representative for the relevant Eligible Participant does not respond by email to the Promoter and complete the online order form by 17:30 (UK time) on 1 May 2026, then their Prize will be forfeited and the Promoter reserves the right to select another winner in accordance with the process described above (but shall not be obliged to do so).
10. Each Prize is non-exchangeable, non-transferable and may not be exchanged for cash.
11. The decision of the Promoter regarding any aspect of the prize draw is final and binding, and no correspondence will be entered into about it.
12. The Promoter must either publish or make available information that indicates that a valid award took place. To comply with this obligation, the Promoter will send the surname and county of the winners and, if applicable a copy of their winning entries, to anyone who emails [juniorexperiences@lfc.co.uk](mailto:juniorexperiences@lfc.co.uk) within one (1) month after the Closing Date stated in condition 3. If you object to any or all of your surname, county and entry being published or made available, please contact the Promoter by email to [juniorexperiences@lfc.co.uk](mailto:juniorexperiences@lfc.co.uk). In such circumstances, the Promoter must still provide the information and entry to the Advertising Standards Authority on request.
13. Eligible Participants (and their nominated representatives) are deemed to have accepted and agreed to be bound by these terms and conditions upon entry. The Promoter reserves the right to refuse entry, or to refuse to award a Prize, to anyone in breach of these terms and conditions.
14. The Promoter reserves the right to hold void, cancel, suspend, or amend the prize draw (including the Prize or any item forming part of the Prize) where it becomes necessary to do so or for administrative reasons without prior notice. The Promoter reserves the right to replace the Prize (or any item forming part of the Prize) with an alternative prize of equal or higher value if circumstances beyond the Promoter's control make it necessary to do so.

15. Where the Promoter or any of its providers makes any changes to the Prize, no compensation or cash equivalent will be available (subject to the Promoter's right set out in condition 14). The Promoter will not be liable for any cancellations or changes to the prize draw or the Prize (in whole or in part), or for any loss or damage. Nothing in these terms shall exclude or limit the liability of the Promoter in relation to personal injury or death caused by the Promoter's negligence or for fraud.

Insofar as is permitted by law, the Promoter, its providers, agents or distributors will not in any circumstances be responsible or liable to compensate any participant(s), or accept any liability for any loss, damage, personal injury or death occurring as a result of claiming a Prize, except where it is caused by the negligence of the Promoter, its providers, agents or distributors or that of their employees. Your statutory rights are not affected.
