

## **App Shirt Giveaway Prize Draw**

### **Terms and Conditions**

1. The prize draw is open to all, except employees of the Promoter, their families, agents or any third party directly associated with administration of the prize draw (including, without limitation, YinzCam, Inc).
2. Entrants who (i) download the official LCFC mobile application (the “**App**”), and (ii) using a unique email address, register a new LCFC.com account to login to the App (the “**Login**”) between 12:00 (UK time) on 24 April, 2025 and 17:00 (UK time) on 8 May, 2025 (the “**Closing Date**”) will automatically be entered into the prize draw.
3. There is no cost to enter. Internet access is required.
4. Any entries made after the Closing Date will not be valid entries and will not be entered into the prize draw.
5. There is a limit of one (1) entry per person.
6. The download and use of the App is subject to the App’s Terms of Use (available at [lcf.com/club/terms](https://lcf.com/club/terms)).

If for any reason a technical interruption, fault or site failure occurs when downloading the App or completing a Login to the App, the Promoter does not take any responsibility for incomplete entries, and any incomplete entries will not be considered valid for entry into the prize draw. The Promoter accepts no responsibility for any entries which are not completed for any reason.
8. One (1) winner will be selected by random draw performed by a computer process on 12 May, 2025. The Promoter will confirm that each winner meets the eligibility criteria set out in these terms and conditions. If a winner does not meet the eligibility criteria, their entry will be deemed void, their Prize will be forfeited, and the Promoter will be entitled (but not obliged) to select another winner in accordance with the process described above.
9. The “**Prize**” will be a 2024/25 season home LCFC replica shirt.
10. The winner will be notified by email (using the details associated with their LCFC.com account) before 17:00 (UK time) on 22 May, 2025 and must provide a valid telephone number to claim their Prize. If a winner does not respond to the

Promoter within seven (7) days of being notified by the Promoter, then their Prize will be forfeited, and the Promoter will be entitled (but not obliged) to select another winner in accordance with the process described above. The Promoter may require each winner to provide proof that they are eligible to enter the prize draw and/or of their identity.

11. The Prize is non-exchangeable, non-transferable and no cash alternative is offered.
