

## **Filbert's Easter Egg Hunt 2026 - Prize Draw Terms and Conditions**

1. The promotion is open to all UK residents, except employees of the Promoter, their families, agents or any third party directly associated with administration of the promotion (including, without limitation, YinzCam, Inc). Entrants aged under 18 must get consent from their parent(s) or legal guardian(s) before entering.
2. The promotion is free to enter and no purchase is necessary.
3. The **"Promotional Period"** shall run from 00:01 on 28 March 2026 to 23:59 on 12 April 2026 (UK times). Entries made after this time will not be valid and will not be entered into the relevant Prize Draw.
4. To enter this promotion, an entrant must (i) download, or already have downloaded, the official LCFC mobile application (the **"App"**), (ii) using a unique email address, register a new LCFC.com account to login to the App or use their existing LCFC.com account to login to the App (the **"Login"**), (iii) collect Easter Egg Points by scanning up to seven (7) unique QR codes located in and around King Power Stadium, Filbert Way, Leicester LE2 7FL), and redeem their Easter Egg Points by entering one of the Prize Draws before the Closing Date detailed in condition 10 below. Each QR code is unique and will only trigger the allocation of Easter Egg Points to the relevant entrant once. Once an entrant's Easter Egg Points have been redeemed against a Prize Draw entry, they cannot be reallocated back to the relevant entrant or redeemed against another Prize Draw. Each entrant may only enter each individual Prize Draw once, but entrants may enter another Prize Draw if they have collected sufficient Easter Egg Points to do so.
5. QR codes shall be located in and around King Power Stadium during the Promotional Period with the following Easter Egg Point allocations:
  - 5.1 QR code 1: equals 300 Easter Egg Points;
  - 5.2 QR code 2: equals 300 Easter Egg Points;
  - 5.3 QR code 3: equals 300 Easter Egg Points;
  - 5.4 QR code 4: equals 300 Easter Egg Points;
  - 5.5 QR code 5: equals 500 Easter Egg Points;
  - 5.6 QR code 6: equals 500 Easter Egg Points; and

- 5.7 QR code 7: equals 1,000 Easter Egg Points.
6. After each entrant has completed the Login to the App and started to build their balance of Easter Egg Points, they may enter a single Prize Draw or multiple Prize Draws (subject to possession of sufficient Easter Egg Points for the relevant Prize Draw(s)). The Prizes available and the Easter Egg Point quantity required to enter the relevant Prize Draw for each Prize will be clearly stated on the 'Enter Draw' page on the app. Once an entrant has entered a Prize Draw, their Easter Egg Point balance will be deducted accordingly.
7. The Promoter shall not be responsible for, and shall not have to accept, entries which do not reach it before the Closing Date and/or are illegible, incomplete, corrupted, lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind.
8. The **"Prize"** will be either:
- 8.1 one (1) LCFC key ring (fifty (50) available in total);
- 8.2 one (1) Filbert Fox soft toy (twenty-five (25) available in total);
- 8.3 one (1) pair of general admission tickets for an LCFC home league match at King Power Stadium during the 2025/26 or 2026/27 season to be agreed with the Promoter (the **"Fixture"**) for the applicable Prize Winner and another named individual (which shall be subject to LCFC's Home Match Ticket Terms and Conditions, available at LCFC.com/terms) (seat locations to be determined by the Promoter acting in its absolute discretion) (five (5) pairs available in total);
- 8.4 one (1) 2025/26 LCFC replica home shirt (one (1) available in total);
- 8.5 one (1) boxed 2025/26 LCFC home shirt signed by the majority of the first team squad (one (1) available in total); or
- 8.6 one (1) pair of Champions Club packages for an LCFC home league match at King Power Stadium during the 2025/26 or 2026/27 season to be agreed with the Promoter (the **"Fixture"**) for the applicable Prize Winner and another named individual (which shall be subject to LCFC's Hospitality Terms and Conditions, available at LCFC.com/terms) (seat locations to be determined by the Promoter acting in its absolute discretion) (one (1) pair available in total).

The Prize described in conditions 8.3 and 8.6 shall each be a **"Fixture Prize"**.

9. Please note that the Prize Winners who win the Prizes described in conditions 8.1 and 8.2 must each collect their Prize from the Foxes Fanstore by 17:00 (UK time) on 29 May 2026. Each Prize Winner will need to bring photographic ID and their confirmation email to the Foxes Fanstore and show them to the Foxes Fanstore staff in order to prove their identity and collect their Prize.
10. One (1) winner will be selected in respect of each Prize listed in condition 8 above (the **“Prize Winners”**, each a **“Prize Winner”**) by random draw performed by a computer process on or after 13 April 2026 (the **“Prize Draw”**). The **“Closing Date”** for entry into the Prize Draw shall be 23:59 (UK time) on 12 April 2026.
11. Entries into the selected Prize Draw(s) which are not successful will not be rolled over into any other Prize Draw(s).
12. There is a maximum of one Prize in respect of each Prize Draw per person. For example, a single entrant may win one Filbert Fox soft toy and one LCFC notepad and pen set, but not two Filbert Fox soft toys. Prize Winners will have no right to choose a Prize and the Club’s decision in respect of the allocation of each Prize is final. The Promoter will confirm that each Prize Winner meets the eligibility criteria set out in these terms and conditions. If a Prize Winner does not meet the eligibility criteria, their entry will be deemed void, their Prize will be forfeited, and the Promoter will be entitled (but not obliged) to select another Prize Winner in accordance with the applicable process described above. The Promoter may require Prize Winners to provide proof that they are eligible to enter the relevant Prize Draw and/or of their identify.
13. The Prize Winners will be notified by email or telephone (using the details associated with their LCFC.com or LCFC App account, as applicable) before 23:59 (UK time) on 27 April 2026. If a Prize Winner does not respond to the Promoter within ten (10) days of being notified by the Promoter, fails to collect their Prize in respect of the Prizes described in conditions 8.1, 8.2, 8.4 and 8.5 by 17:00 (UK time) on 29 May 2026, or fails to book their Fixture Prize by 17:00 (UK time) on 31 December 2026), then that Prize Winner's Prize will be forfeited and the Promoter will be entitled, but not obliged, to select another Prize Winner in accordance with the process described above. Entrants must provide a valid phone number and email address to claim any Prize.
14. The Fixture Prizes described in conditions 8.3 and 8.6 shall also be subject to the following conditions:
  - 14.1 all tickets/packages must be booked for the same Fixture;
  - 14.2 the Fixture Prize may only be used by the applicable Prize Winner and up to one (1) accompanying guest;

- 14.3 where the Prize Winner is aged under 16, their guest must be a responsible adult accompanying them to the Fixture;
- 14.4 the Prize Winner will need to bring photographic ID to the Fixture to prove their identity and collect the tickets which form part of the Fixture Prize;
- 14.5 the Fixture Prize is only valid for the relevant Fixture it has been booked for;
- 14.6 no refund shall be payable in the event the Prize Winner has purchased a 2025/26 or 2026/27 Season Ticket, hospitality package, match ticket or other admission ticket for the Fixture (as applicable);
- 14.7 if the Prize Winner fails to collect their Fixture Prize by the kick-off time of the Fixture or cannot attend the Fixture, their Fixture Prize will be forfeited; and
- 14.8 the scheduling of the applicable Fixture is subject to change, and should it be rescheduled to take place at a new time or date which the Prize Winner cannot attend, they should contact the Promoter as soon as they can to request a transfer to another LCFC home league match during the 2025/26 or 2026/27 Season. The Promoter reserves the right to deny any transfer as detailed in the applicable Home Match Ticket and Hospitality Terms and Conditions which are available at [LCFC.com/terms](http://LCFC.com/terms).
15. All costs and expenses not included in the description of the applicable Prize are the responsibility of the relevant Prize Winner. All items forming each Prize are subject to their individual availability.
16. Each Prize is subject to these terms and conditions, along with any other terms and conditions that apply to each of the items forming the Prize and that may be notified to the Prize Winner by the Promoter and/or the provider of the applicable item (for example, each Fixture Prize shall be subject to the terms and conditions applicable to them which are available at [LCFC.com/terms](http://LCFC.com/terms)) (all such terms and conditions together forming the “**Terms and Conditions**”). In the event of any conflict between the Terms and Conditions, and these prize draw terms and conditions, these prize draw terms and conditions will take precedence.
17. Each Prize is subject to availability.
18. The Promoter reserves the right to amend the promotion, any Prize Draw(s), any Prize or any item forming part of any Prize for administrative reasons without prior notice.

19. Each Prize is non-transferable and may not (subject to the Promoter's right set out in condition 14.8) be exchanged for cash.
20. The decision of the Promoter regarding any aspect of the promotion is final and binding and no correspondence will be entered into about it.
21. The Promoter must either publish or make available information that indicates that a valid award took place. To comply with this obligation, the Promoter will send the surname and county of major prize winners and, if applicable copies of their winning entries, to anyone who emails [find.filbert@lcf.co.uk](mailto:find.filbert@lcf.co.uk) within one month after the Promotional Period stated in condition 3 has concluded. If you object to any or all of your surname, county and winning entry being published or made available, please contact the Promoter at [find.filbert@lcf.co.uk](mailto:find.filbert@lcf.co.uk). In such circumstances, the Promoter must still provide the information and winning entry to the UK's Advertising Standards Authority on request.
22. Participants are deemed to have accepted and agreed to be bound by these terms and conditions upon entry. The parent(s) or legal guardian(s) of entrants under 18 agree to these terms and conditions on behalf of the entrant. The Promoter reserves the right to refuse entry, or refuse to award any Prize(s), to anyone in breach of these terms and conditions.
23. The Promoter reserves the right to hold void, cancel, suspend, or amend the promotion or any Prize where it becomes necessary to do so.
24. Where the Promoter or any of its providers makes any changes to the Prize(s) (in whole or in part), no compensation or cash equivalent will be available (subject to the Promoter's right set out in condition 14.8). The Promoter will not be liable for any cancellations or changes to the promotion or the Prizes (in whole or in part), or for any loss or damage. Nothing in these terms shall exclude or limit the liability of the Promoter in relation to personal injury or death caused by the Promoter's negligence or for fraud.

Insofar as is permitted by law, the Promoter, its providers, agents or distributors will not in any circumstances be responsible or liable to compensate any Prize Winner or any accompanying guest, or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up any Prize except where it is caused by the negligence of the Promoter, its providers, agents or distributors or that of their employees.
