

Luke Thomas Boots - App Prize Draw

Terms and Conditions

1. The prize draw is open to UK residents aged 16 years or over, except employees of the Promoter, their families, agents or any third party directly associated with administration of the prize draw (including, without limitation, YinzCam, Inc). Entrants under 18 must get consent from their parent(s) or legal guardian(s) before entering.
2. Eligible participants who (i) download, or already have downloaded, the official LCFC mobile application (the “**App**”), and (ii) using a unique email address, register a new LCFC.com account to login to the App or use their existing LCFC.com account to login to the App (the “**Login**”) between 10:00 (UK time) on 19 September 2025 and 17:00 (UK time) on 26 September 2025 (the “**Closing Date**”) will automatically be entered into the prize draw.
3. The prize draw is free to enter. Internet access is required.
4. Any entries made after the Closing Date will not be valid entries and will not be entered into the prize draw.
5. There is a limit of one (1) entry per person.
6. The download and use of the App is subject to the App’s Terms of Use (available at lcfc.com/club/terms).

If for any reason a technical interruption, fault or site failure occurs when downloading the App or completing a Login to the App, the Promoter does not take any responsibility for incomplete entries, and any incomplete entries will not be considered valid for entry into the prize draw. The Promoter accepts no responsibility for any entries which are not completed for any reason.
8. One (1) winner will be selected by random draw performed by a computer process on or before 30 September 2025. The Promoter will confirm that the winner meets the eligibility criteria set out in these terms and conditions. If the winner does not meet the eligibility criteria, their entry will be deemed void, their Prize will be forfeited, and the Promoter will be entitled (but not obliged) to select another winner in accordance with the process described above.
9. The “**Prize**” will be one (1) match-worn pair of football boots signed by Luke Thomas.

10. The winner will be notified by email (using the details associated with their LCFC.com account) before 17:00 (UK time) on 10 October 2025, and must provide a valid postal address and telephone number to claim their Prize (unless they prefer to collect the Prize from the Foxes Fanstore in which case they must notify the Promoter of such preference). If the winner does not respond to the Promoter within seven (7) days of being notified by the Promoter, then their Prize will be forfeited, and the Promoter will be entitled (but not obliged) to select another winner in accordance with the process described above. The Promoter may require the winner to provide proof that they are eligible to enter the prize draw and/or of their identity. Unless the winner elects to collect their prize as described above, the prize will be sent by post within ten (10) days of their response to the Promoter in accordance with the process set out above.
11. The Prize is non-exchangeable, non-transferable and no cash alternative is offered.
12. The decision of the Promoter regarding any aspect of the prize draw is final and binding, and no correspondence will be entered into about it.
13. The Promoter must either publish or make available information that indicates that a valid award took place. To comply with this obligation, the Promoter will send the surname and county of the winner and, if applicable a copy of their winning entry, to anyone who emails competitions@lcfc.co.uk within one (1) month after the Closing Date stated in condition 2. If you object to any or all of your surname, county and winning entry being published or made available, please contact the Promoter by email to competitions@lcfc.co.uk. In such circumstances, the Promoter must still provide the information and winning entry to the Advertising Standards Authority on request.
14. If you complete the steps detailed in condition 2 (thereby entering the prize draw), but do not wish to be entered into the prize draw, please email competitions@lcfc.co.uk before 17:00 (UK time) on 26 September 2025.
15. Participants are deemed to have accepted and agreed to be bound by these terms and conditions upon entry. The parent(s) or legal guardian(s) of entrants under 18 agree to these terms and conditions on behalf of the entrant. The Promoter reserves the right to refuse entry, or refuse to award the Prize, to anyone in breach of these terms and conditions.
16. The Promoter reserves the right to hold void, cancel, suspend, or amend the Prize or the prize draw where it becomes necessary to do so. The Promoter reserves the right to substitute the Prize with another prize of equal or greater value at its absolute discretion.

Insofar as is permitted by law, the Promoter, its partners, agents or distributors (including YinzCam) will not in any circumstances be responsible or liable to compensate any winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the Prize except where it is caused by the negligence of the Promoter, its partners, agents or distributors or that of their employees. Your statutory rights are not affected.
