

LCFC Women v West Ham Women – Signed Shirt Prize Draw

Terms and Conditions

1. The prize draw is open to UK residents aged 16 years or over, except employees of the Promoter, their families, agents or any third party directly associated with administration of the prize draw. Entrants under 18 must get consent from their parent(s) or legal guardian(s) before entering.
2. Upon purchase from the Promoter of at least one LCFC Women 2024/25 Season Ticket, LCFC Women 2024/25 Half Season Ticket, or a match ticket or hospitality package for Leicester City Women Football Club's Barclays Women's Super League fixture against West Ham United Women Football Club (currently scheduled for 12:30 (UK time) on Saturday 10 May 2025) (the "**Match**") and subsequent attendance at the Match, you will be automatically entered into the prize draw (a "**Qualifying Entry**"). There is no additional cost to enter other than the standard cost of purchasing a season ticket, half season ticket, match ticket or hospitality package.
3. The automatic entry described in condition 2 above applies to Qualifying Entries made before the Matchday Ticket Office and turnstiles for the Match have closed for entry ("**Closing Date**"). Purchases and entries to the Match made after this time will not be valid entries and will not be entered into the prize draw.
4. Season Tickets, Half Season Tickets, Match tickets and hospitality packages are subject to the LCWFC 2024/2025 Home Match Ticket, Season Ticket and/or Hospitality Terms and Conditions (as applicable) and the King Power Stadium Ground Regulations found at lcf.com/terms.
5. Each Qualifying Entry will amount to one entry into the prize draw only, irrespective of the total number of tickets or hospitality packages purchased. The ticket owner in relation to the relevant Qualifying Entry will be entered into the prize draw.
6. If for any reason a technical interruption, fault or site failure occurs when purchasing online or entering King Power Stadium, the Promoter does not take any responsibility for incomplete purchases or entries, and any incomplete purchases and/or entries will not be considered valid for entry into the prize draw. The Promoter accepts no responsibility for any purchases or entries which are not completed for any reason.
7. One (1) winner will be selected by random draw performed by a computer process on or after 12 May 2025. The Promoter will confirm that the winner selected meets the eligibility criteria set out in these terms and conditions, and reserves the right to require the winner to provide proof that they are eligible to enter the prize draw and/or

of their identity. If the winner does not meet the eligibility criteria, their entry will be deemed void, their prize will be forfeited, and the Promoter will be entitled to select another winner in accordance with the process described above.

8. The “**Prize**” will be one (1) replica Leicester City Women’s home shirt 2024/25 signed by Yuka Momiki. There is one (1) Prize to be won.
9. The winner will be notified by email or telephone (using the details associated with their ticketing account) before 17:00 (UK time) on 19 May 2025 and must provide a valid UK postal address and phone number to claim their Prize (unless they prefer to collect the Prize from the Promoter’s Foxes Fanstore in which case they must notify the Promoter of such preference). If the winner does not respond by email to the Promoter within seven (7) days of being notified by the Promoter, then that winner's Prize will be forfeited and the Promoter will be entitled (but not obliged) to select another winner in accordance with the process described above.
10. Unless the winner elects to collect their Prize as described above, the Prize will be sent to the winner by post within 10 days of them validly claiming their Prize in accordance with condition 9 above.
11. The Prize is non-exchangeable, non-transferable and no cash alternative is offered.
12. The decision of the Promoter regarding any aspect of the prize draw is final and binding and no correspondence will be entered into about it.
13. The Promoter must either publish or make available information that indicates that a valid award took place. To comply with this obligation, the Promoter will send the surname and county of the winner and, if applicable, a copy of their winning entry, to anyone who emails competitions@lfc.co.uk within one (1) month after the Closing Date stated in condition 3. In such circumstances, the Promoter must still provide the information and winning entry to the Advertising Standards Authority on request.
14. If you make a Qualifying Entry but do not wish to be entered into the prize draw, please email competitions@lfc.co.uk before 09:00 (UK time) on 12 May 2025.
15. Entrants are deemed to have accepted and agreed to be bound by these terms and conditions upon entry. The parent(s) or legal guardian(s) of entrants under 18 agree to these terms and conditions on behalf of the entrant. The Promoter reserves the right to refuse entry, or to refuse to award the Prize, to anyone in breach of these terms and conditions.
16. The Promoter reserves the right to hold void, cancel, suspend, or amend the Prize or the prize draw where it becomes necessary to do so.

Insofar as is permitted by law, the Promoter, its providers, agents or distributors will not in any circumstances be responsible or liable to compensate any winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the Prize, except where it is caused by the negligence of the Promoter, its providers, agents or distributors or that of their employees.
