

## **LCFC App - Match Predictor Competition 2025/26**

### **Terms and Conditions**

1. The competition is open to all UK residents aged 18 years or over, except employees of the Promoter, their families, agents or any third party directly associated with administration of the competition (including, without limitation, YinzCam, Inc).
2. To enter the competition, eligible participants must (i) download (or have already downloaded) the official LCFC mobile application (the **"App"**), (ii) register a new LCFC.com account to login to the App or use their existing LCFC.com or LCFC App account to login to the App (**"Login"**), and (iii) select and register a prediction in the 'Match Predictor' section of the App (a **"Prediction"**) during an Entry Period (as defined below).
3. There is no additional cost to enter. Internet access is required.
4. Participants must provide valid and accurate personal details in order to enter the competition and claim a Prize. Each participant will be allocated a randomly generated username which will feature on the Match Predictor competition leaderboard. The Promoter may, at its discretion, enable participants to edit their usernames during the Competition Period. Participants must not use offensive or inappropriate usernames. The Promoter reserves the right, acting in its absolute discretion, to (i) require a participant to change their username, (ii) change any username, and/or (iii) exclude a participant from the competition, in the event of an offensive and/or inappropriate username being used. The Promoter also reserves the right to exclude participants who (or attempt to) violate the rules, cheat or sabotage the competition.
5. The **"Main Competition Period"** shall run from 12:00 (UK time) on 6 August 2025 to 23:00 (UK time) on 2 May 2026 (or 23:00 (UK time) on the day of LCFC's last regular EFL Championship fixture of the 2025/26 season, if different).
6. Eligible participants will be able to select a Prediction during an **"Entry Period"** in respect of each of LCFC's forty-six (46) regular season EFL Championship fixtures during the 2025/26 season (each a **"Match"**). Each Entry Period shall open and close at such times as may be determined by the Promoter, but shall not open in respect of a Match until after the conclusion of the previous Match and close no later than kick-off of the applicable Match. Participants may change their predictions in respect of each Match at any point during the applicable Entry Period and the most recent selection made immediately before closure of the applicable Entry Period shall be counted as their Prediction for that Match for the purposes of participating in the competition. There is no requirement for participants to select a Prediction for every Match and participants

will continue to participate in the competition irrespective of the number of Predictions they make during the Competition Period.

7. Any Predictions made outside of an Entry Period will not be valid and will not be eligible to score points in accordance with the Scoring System set out in the Schedule. Entries received which are not submitted via the App will not be accepted. Use of script, macro or any automated system to enter the competition is prohibited and entries made (or which appear to have been made) using any such system may be treated as void. Any illegible, incomplete or fraudulent entries will be rejected.
8. There is a limit of one (1) Prediction per Match per person.
9. The download and use of the App is subject to the App's Terms of Use (available at [lcfc.com/club/terms](http://lcfc.com/club/terms)).
10. The Promoter does not take any responsibility for incomplete Predictions and/or entries, and any incomplete Predictions and/or entries will not be considered valid for entry into the competition. The Promoter accepts no responsibility for any Predictions and/or entries which are not completed for any reason, including but not limited to if for any reason a technical interruption, fault or site failure occurs when downloading the App, completing a Login to the App and/or selecting a Prediction.
11. Following expiry of the Main Competition Period, the three (3) eligible participants who have accumulated the highest number of points (in accordance with the Scoring System set out in the Schedule) will be the **"Main Prize Winners"**. In the event of a draw for first, second and/or third place, the applicable Main Prize Winner will be selected by a random draw of the tied individuals performed by a computer process.
12. There are three (3) Main Prizes available, with the applicable Main Prize being allocated to each Main Prize Winner in accordance with condition 15 below. The **"Main Prize"** will be either:
  - 12.1 two (2) LCFC 2026/27 Season Tickets for block A1 or C2 at King Power Stadium for the Main Prize Winner and another named individual (seat locations to be determined by the Promoter acting in its absolute discretion);
  - 12.2 one (1) set of four (4) Level 1 Premium GA packages for an LCFC home league match at King Power Stadium during the 2026/27 season to be agreed with the Promoter (the **"Fixture"**), and shall include the following items only:
    - (a) four (4) match tickets to the Fixture (the seat location of which shall be at the discretion of the Promoter and subject to availability);
    - (b) food and drink vouchers (at a value and for such concessions as to be determined by the Promoter acting in its absolute discretion); and

- (c) two (2) complimentary matchday programmes; or
- 12.3 one (1) framed replica LCFC home shirt 2025/26 (Adults) signed by the majority of the LCFC first team squad.
- 13. The Main Prize described in condition 12.1 above shall be subject to LCFC's Season Ticket 2026/27 Terms and Conditions (which shall be made available at [LCFC.com/terms](http://LCFC.com/terms)). In the event that the applicable Main Prize Winner has already purchased an LCFC 2026/27 Season Ticket by the end of the Competition Period, the Promoter may decide to, but shall be under no obligation to, refund a portion of the price paid by that Main Prize Winner for their Season Ticket or offer them an alternative prize.
- 14. The Main Prize described in condition 12.2 above shall be subject to LCFC's Home Match Ticket 2026/27 Terms and Conditions (which shall be made available at [LCFC.com/terms](http://LCFC.com/terms)) and the following conditions:
  - 14.1 all four packages must be booked for the same Fixture;
  - 14.2 the Main Prize may only be used by the applicable Main Prize Winner and up to three (3) accompanying guests;
  - 14.3 the Main Prize Winner will need to bring photographic ID to the Fixture to prove their identity and collect the tickets which form part of the Main Prize;
  - 14.4 the Main Prize is only valid for the Fixture;
  - 14.5 no refund shall be payable in the event the Main Prize Winner has purchased a 2026/27 Season Ticket, hospitality package or other admission ticket for the Fixture;
  - 14.6 if the Main Prize Winner fails to collect their Main Prize by the kick-off time of the Fixture or cannot attend the Fixture, their Main Prize will be forfeited; and
  - 14.7 the scheduling of the Fixture is subject to change, and should it be rescheduled to take place at a new time or date which the Prize Winner cannot attend, they should contact the Promoter as soon as they can to request a transfer to another LCFC home league match during the 2026/27 Season. The Promoter reserves the right to deny any transfer as detailed in the 2026/2027 Home Match Ticket Terms and Conditions which shall be made available at [LCFC.com/terms](http://LCFC.com/terms).
- 15. The Main Prize Winner who has accumulated the highest number of points during the Competition Period will win the Main Prize described in condition 12.1. The Main Prize Winner who has accumulated the second highest number of points during the Competition Period will win the Main Prize described in condition 12.2. The Main Prize Winner who has accumulated the third highest number of points during the Competition Period will win the Prize described in condition 12.3.

16. Each “**Monthly Competition Period**” shall run from 00:00 (UK time) on the first day of each calendar month to 23:59 (UK time) on the last day of each calendar month during the Main Competition Period, with the exception of (i) August’s Monthly Competition Period which shall run from 12:00 (UK time) on 6 August 2025 (the start of the Main Competition Period) to 23:59 (UK time) on 31 August 2025, and (ii) May’s Monthly Competition Period which shall run from 00:00 (UK time) on 1 May 2026 to 23:00 (UK time) on 2 May 2026 (or 23:00 (UK time) on the day of LCFC’s last regular EFL Championship fixture of the 2025/26 season, if different) (the end of the Main Competition Period).
17. Following expiry of each Monthly Competition Period during the Main Competition Period, the one (1) eligible participant who has accumulated the highest number of points (in accordance with the Scoring System set out in the Schedule) in respect of Matches which have taken place during that Monthly Competition Period will be the “**Monthly Prize Winner**”. In the event of a draw for first place, the applicable Monthly Prize Winner will be selected by a random draw of the tied individuals performed by a computer process.
18. There is one (1) Monthly Prize available per Monthly Competition Period (ten (10) in total across the Main Competition Period). The “**Monthly Prize**” will be one (1) LCFC football signed by the majority of the LCFC first team squad.
19. At random intervals during the Main Competition Period (to be determined by the Promoter acting in its absolute discretion), up to ten (10) eligible participants in total will be selected by a random draw performed by a computer process to be the “**Spot Prize Winners**”.
20. There are ten (10) Spot Prizes available across the Main Competition Period (one (1) per Spot Prize Winner), with the applicable Spot Prize being allocated to each Spot Prize Winner by the Promoter acting in its absolute discretion. The “Spot Prize” will be either:
  - 20.1 one (1) replica LCFC home shirt 2025/26 (Adults) (one (1) available in total);
  - 20.2 one (1) replica LCFC away shirt 2025/26 (Adults) (one (1) available in total);
  - 20.3 one (1) replica LCFC third shirt 2025/26 (Adults) (one (1) available in total);
  - 20.4 one (1) LCFC insulated mug (two (2) available in total);
  - 20.5 one (1) LCFC flask (two (2) available in total); or
  - 20.6 one (1) LCFC scarf (three (3) available in total).
21. The Main Competition Period and the Monthly Competition Period(s) shall together be deemed to be the “**Competition Period**”. The Main Prize Winner(s), the Monthly Prize

Winner(s) and the Spot Prize Winner(s) shall together be deemed to be the **“Prize Winner(s)”**. The Main Prize(s), the Monthly Prize(s) and the Spot Prize(s) shall together be deemed to be the **“Prize(s)”**.

22. Prize Winners will have no right to choose a Prize and the Club’s decision in respect of the allocation of each Prize is final.
23. The Promoter will confirm that each Prize Winner meets the eligibility criteria set out in these terms and conditions. If a Prize Winner does not meet the eligibility criteria, their entry will be deemed void, their Prize will be forfeited, and the Promoter will be entitled (but not obliged) to select another Prize Winner in accordance with the applicable process described above (i.e. the eligible participant that has accumulated the next highest number of points or another eligible participant who has been selected by a random draw performed by a computer process).
24. The Prize Winners will be notified by email (using the details associated with their LCFC.com or LCFC App account, as applicable) before 17:00 (UK time) on the seventh day after the applicable Competition Period has ended with details of how to claim their Prize. If a Prize Winner does not respond to the Promoter within seven (7) days of being notified by the Promoter, then that Prize Winner's Prize will be forfeited, and the Promoter will be entitled (but not obliged) to select another Prize Winner in accordance with the process described above. The Promoter may require each Prize Winner to provide proof that they are eligible to enter the competition and/or of their identity.
25. All costs and expenses not included in the description of the applicable Prize are the responsibility of the relevant Prize Winner.
26. Each Prize is non-exchangeable, non-transferable and no cash alternative is offered.
27. The decision of the Promoter regarding any aspect of the competition is final and binding and no correspondence will be entered into about it.
28. The Promoter must either publish or make available information that indicates that a valid award took place. To comply with this obligation, the Promoter will send the surname and county of the Prize Winners and, if applicable copies of their winning entries, to anyone who emails [competitions@lcfc.co.uk](mailto:competitions@lcfc.co.uk) within one (1) month after the Main Competition Period has ended. If you object to any or all of your surname, county and winning entry being published or made available, please contact the Promoter by email to [competitions@lcfc.co.uk](mailto:competitions@lcfc.co.uk). In such circumstances, the Promoter must still provide the information and winning entry to the Advertising Standards Authority on request.

29. Participants are deemed to have accepted and agreed to be bound by these terms and conditions upon entry. The Promoter reserves the right to refuse entry, or to refuse to award the Prize, to anyone in breach of these terms and conditions.
30. The Promoter reserves the right to hold void, cancel, suspend, or amend each Prize, any item(s) forming part of each Prize or the competition where it becomes necessary to do so and/or for administrative reasons without prior notice. The Promoter reserves the right to substitute each Prize with another prize of equal or greater value at its absolute discretion.
31. Insofar as is permitted by law, the Promoter, its partners, agents or distributors (including YinzCam) will not in any circumstances be responsible or liable to compensate a Prize Winner and/or their guests, or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the Prize except where it is caused by the negligence of the Promoter, its partners, agents or distributors or that of their employees. Your statutory rights are not affected.
32. Personal data supplied during the course of this competition will be processed (i) to administer and operate the competition, (ii) in respect of the usernames and Predictions of participants and Prize Winners, for reasonable promotional purposes, and (iii) as set out in the Promoter's privacy policy available on [lfc.com/terms](https://lfc.com/terms). See also condition 28 with regard to the announcement of Prize Winners.
33. This competition is in no way sponsored, endorsed or administered by, or associated with, Apple, Google, Instagram, Facebook, X (Twitter), TikTok, LinkedIn and/or any other social media platform, and such entities shall have no liability to participants.
34. The competition will be governed by English law and entrants to the competition submit to the exclusive jurisdiction of the English courts.
35. The Promoter of this competition is Leicester City Football Club Limited whose registered office is at King Power Stadium, Filbert Way, Leicester LE2 7FL.

## Schedule

The “**Scoring System**” for each Match shall be as follows:

- ‘What will the full-time score be?’ **20** points for a correct Prediction
- ‘When will the first goal be scored?’ **30** points for a correct Prediction
- ‘Which team will have the most possession?’ **5** points for a correct Prediction
- ‘Which side will score first?’ **10** points for a correct Prediction
- ‘How many shots will there be overall?’ **10** points for a correct Prediction
- **5** points for each Match a Prediction is made in respect of
- **10** points for each Monthly Competition Period in which a Prediction is made in respect of every Match which takes place during that Monthly Competition Period

General Scoring System terms:

- a. If a Match is cancelled, no points will be awarded in respect of the cancelled Match.
- b. If a Match is rescheduled, points will be awarded in accordance with the Scoring System for the rescheduled Match.
- c. The Match data used for the determination of the kick-off time and the calculation of points is supplied by Stats Perform and once a score has been marked as final, it will not be changed. The Promoter will not enter into discussions around any of the statistics used to calculate a participant’s score.
- d. If a goal is scored in stoppage time, such goal will be recorded as being scored on 45+ or 90+ minutes, as applicable.
