

Filbert Easter Visit 2026 - Prize Draw

Terms and Conditions

1. The prize draw is open to any UK resident aged 18 years or over who is the legal parent, guardian, or carer of an **“Eligible Child”** (meaning a child who is registered with an eligible school or grassroots football club invited by the Promoter to participate in this prize draw), except employees of the Promoter, their families, agents or any third party directly associated with administration of the prize draw.
2. There is no additional cost to enter. Internet access is required.
3. The prize draw closes at 23:59 (UK time) on 12 April 2026 (the **“Closing Date”**). Entries made after the Closing Date will not be valid and will not be entered into the prize draw.
4. To enter this prize draw, the Eligible Child’s parent, guardian or carer (the **“Entrant”**) must (i) access the online entry form (available in the communications shared directly by the Promoter with the eligible schools and grassroots football clubs), and (ii) complete all required fields in the online form, before the Closing Date detailed in condition 3 above. Only one entry is permitted per Eligible Child. Duplicate entries will not be valid and will not be included in the prize draw.
5. The Promoter accepts no responsibility for entries not successfully completed due to a technical fault, technical malfunction, computer hardware or software failure, satellite, network or server failure of any kind. Entrants must provide a valid phone number and email address to claim the Prize.
6. One (1) winner will be selected by random draw performed by a computer process on or after 13 April 2026. The Promoter will check that the winner selected meets the eligibility criteria set out in these terms and conditions. If the winner does not meet the eligibility criteria, their entry will be deemed void, their Prize will be forfeited, and the Promoter will be entitled to select another winner in accordance with the process described above.
7. There is one (1) Prize to be won. The winner will receive the opportunity for Filbert Fox to visit them at their school or grassroots football club on a date to be agreed between their school/grassroots football club and the Promoter (the **“Prize”**). Please note that the Prize may only be claimed by an eligible Entrant for use by an Eligible Child and fulfilment of the Prize is subject to the agreement of the Eligible Child’s school/grassroots football club (as applicable).

8. The winner will be notified by email or telephone (using the details provided at entry) before 17:00 (UK time) on 27 April 2026, with details of how to claim their Prize. If a winner fails to respond to the Promoter by 17:00 (UK time) on 31 May 2026 or the relevant Eligible Child's school/grassroots football club does not agree to accept the Prize on a date convenient to the Promoter, then that winner's Prize will be forfeited and the Promoter reserves the right to select another winner in accordance with the process described above (but shall not be obliged to do so). The Promoter does not accept any responsibility or liability if you are unable to take up the Prize within the timescales set out in these terms and conditions.
9. The Prize is non-transferable and may not be exchanged for cash.
10. The decision of the Promoter regarding any aspect of the prize draw is final and binding, and no correspondence will be entered into about it.
11. The Promoter must either publish or make available information that indicates that a valid award took place. To comply with this obligation, the Promoter will send the surname and county of the winner and, if applicable, a copy of their winning entry, to anyone who emails help@lcfc.co.uk within one (1) month after the Closing Date stated in condition 3. If you object to any or all of your surname, county and winning entry being published or made available please contact the Promoter by email to help@lcfc.co.uk. In such circumstances, the Promoter must still provide the information and winning entry to the Advertising Standards Authority on request.
12. Entrants are deemed to have accepted and agreed to be bound by these terms and conditions upon entry. The Promoter reserves the right to refuse entry, or to refuse to award the Prize, to anyone in breach of these terms and conditions.
13. The Promoter reserves the right to hold void, cancel, suspend, or amend the Prize (or any item(s) forming part of the Prize) or the prize draw where it becomes necessary to do so or for administrative reasons without prior notice. The Promoter reserves the right to replace the Prize with an alternative prize of equal or higher value if circumstances beyond the Promoter's control make it necessary to do so.
14. Where the Promoter or any of its providers makes any changes to the Prize or the Match, no compensation or cash equivalent will be available (subject to the Promoter's right set out in condition 13). The Promoter will not be liable for any cancellations or changes to the prize draw or the Prize (in whole or in part), or for any loss or damage. Nothing in these terms shall exclude or limit the liability of the Promoter in relation to personal injury or death caused by the Promoter's negligence or for fraud.
15. Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate any winner(s) or accept any liability for any loss, damage, personal injury or death occurring as a result of taking

up the Prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Your statutory rights are not affected.
