

## Season Ticket Holders - March 2026 Prize Draw

### Terms and Conditions

1. The prize draw is open to all current 2025/2026 Adult LCFC Men's Season Ticket Holders, 2025/2026 Adult LCFC Women's Season Ticket Holders, 2025/2026 Junior LCFC Men's Season Ticket Holders and 2025/2026 Junior LCFC Women's Season Ticket Holders, except employees of the Promoter, their families, agents or any third party directly associated with administration of the prize draw (including, without limitation, YinzCam, Inc). Entrants aged under 18 must get consent from their parent(s) or legal guardian(s) before entering. Entrants aged under 16 must get a parent or legal guardian to enter on their behalf (please see condition 3 below).
2. To enter the prize draw, eligible participants aged 16+ must (i) download, or already have downloaded, the official LCFC mobile application (the "**App**"), (ii) using a unique email address, register a new LCFC.com account to login to the App or use their existing LCFC.com account to login to the App (the "**Login**"), and (iii) select and register an answer to the March prize draw question in the 'Monthly Prize Draws' section of the App (an "**Entry**") between 00:01 (UK time) on 1 March 2026 and 17:00 (UK time) on 23 March 2026 (the "**Closing Date**").
3. To enter the prize draw on behalf of one or more eligible participants aged under 16, their parent or legal guardian must (i) download, or already have downloaded, the official LCFC mobile application (the "**App**"), (ii) using a unique email address, register a new LCFC.com account to login to the App or use their existing LCFC.com account to login to the App (the "**Login**"), and (iii) complete and submit the online form in the 'Junior Season Ticket Holder Monthly Prize Draw Entry' section of the App for the March prize draw (including but not limited to providing each eligible participant's LCFC supporter number and providing an answer to the March prize draw question) (an "**Entry**") between 00:01 (UK time) on 1 March 2026 and 17:00 (UK time) on 23 March 2026 (the "**Closing Date**").
4. There is no additional cost to enter. Internet access is required.
5. Any Entries made after the Closing Date will not be valid entries and will not be entered into the prize draw. Participants may change their answer to the March prize draw question at any point before the Closing Date and the most recent selection made immediately before the Closing Date shall be counted as their Entry for the purposes of participating in the prize draw.
6. There is a limit of one (1) entry per eligible participant. Duplicate Entries will not be valid and will not be included in the prize draw. The Promoter will not accept entries

that are automatically generated by computer, completed by third parties or in bulk, illegible or incomplete.

7. The download and use of the App is subject to the App's Terms of Use (available at [lcfc.com/club/terms](https://lcfc.com/club/terms)).
8. If for any reason a technical interruption, fault or site failure occurs when downloading the App, completing a Login to the App or completing an Entry, the Promoter does not take any responsibility for incomplete entries, and any incomplete entries will not be considered valid for entry into the prize draw. The Promoter accepts no responsibility for any entries which are not completed for any reason. The Promoter will not accept proof of transmission as proof of receipt of entry to the prize draw.
9. Please note that it may take up to two hours from the completed purchase of a Season Ticket for purchasers to gain entry to the relevant section of the App in order to complete an Entry. If you have purchased a Season Ticket less than two hours before the Closing Date and are not able to access the prize draw via the App then you will not be eligible to enter the prize draw. The Promoter takes no responsibility for purchases completed too close to the Closing Date to enable entry into the prize draw.
10. All Entries containing the correct answer will be entered into the prize draw. One (1) winner will be selected by random draw performed by a computer process on or before 27 March 2026. The Promoter will confirm that each winner meets the eligibility criteria set out in these terms and conditions. If a winner does not meet the eligibility criteria, their entry will be deemed void, their Prize will be forfeited, and the Promoter will be entitled (but not obliged) to select another winner in accordance with the process described above.
11. The "**Prize**" will be one (1) pair of two (2) Fosse Club hospitality passes for one of LCFC's remaining 2025/2026 EFL Championship home fixtures at King Power Stadium, such fixture to be agreed with the Promoter subject to availability (the "**Fixture**"). There is one Prize available in total.
12. The Prize is subject to these terms and conditions, along with the 2025/2026 LCFC Hospitality Terms and Conditions, and LCFC's Ground Regulations (both available at [lcfc.com/terms](https://lcfc.com/terms)). The Prize must be booked and taken before 25 April 2026 or it shall be deemed to have been forfeited. The Prize may only be used by the winner and up to one (1) accompanying guest. If the winner is aged under 16, then their guest must be their parent or guardian in order for them to claim and use the Prize.
13. The winner (or their parent/legal guardian if aged under 16) will be notified by email (using the details associated with their LCFC.com account) before 17:00 (UK time) on 27 March 2026. If the winner does not respond to the Promoter within seven (7) days of being notified by the Promoter, then their Prize will be forfeited, and the Promoter will

be entitled (but not obliged) to select another winner in accordance with the process described above. The Promoter may require the winner to provide proof that they are eligible to enter the prize draw and/or of their identity. The winner will need to bring photographic ID to the Fixture to prove their identity and collect the tickets which form part of the Prize.

16. The Promoter reserves the right to amend or cancel the Prize, or any item(s) forming part of the Prize, for administrative reasons without prior notice. Please note that the scheduling of the Fixture is subject to change, and should it be rescheduled to take place at a new time or date which the winner cannot attend, they should contact [hospitalitysales@lcfc.co.uk](mailto:hospitalitysales@lcfc.co.uk) as soon as they can to request a transfer to another LCFC EFL Championship home match during the 2025/2026 season. The Promoter reserves the right to deny any transfer as detailed in the 2025/2026 Hospitality Terms and Conditions found at [lcfc.com/terms](http://lcfc.com/terms).
17. The decision of the Promoter regarding any aspect of the prize draw is final and binding, and no correspondence will be entered into about it.
18. The Promoter must either publish or make available information that indicates that a valid award took place. To comply with this obligation, the Promoter will send the surname and county of the winner and, if applicable, a copy of their winning entry, to anyone who emails [competitions@lcfc.co.uk](mailto:competitions@lcfc.co.uk) within one (1) month after the Closing Date stated in condition 2 and 3. If you object to any or all of your surname, county and winning entry being published or made available, please contact the Promoter by email to [competitions@lcfc.co.uk](mailto:competitions@lcfc.co.uk). In such circumstances, the Promoter must still provide the information and winning entry to the Advertising Standards Authority on request.
19. Participants are deemed to have accepted and agreed to be bound by these terms and conditions upon entry. The parent(s) or legal guardian(s) of entrants under 18 agree to these terms and conditions on behalf of the entrant. The Promoter reserves the right to refuse entry, or refuse to award the Prize, to anyone in breach of these terms and conditions.
20. The Promoter reserves the right to hold void, cancel, suspend, or amend the Prize or the prize draw where it becomes necessary to do so. The Promoter reserves the right

to substitute the Prize with another prize of equal or greater value at its absolute discretion.

21. Where the Promoter or any of its providers makes any changes to the Prize or the Fixture, no compensation or cash equivalent will be available (subject to the Promoter's right set out in condition 16). The Promoter will not be liable for any cancellations or changes to the prize draw or the Prize (in whole or in part), or for any loss or damage. Nothing in these terms shall exclude or limit the liability of the Promoter in relation to personal injury or death caused by the Promoter's negligence or for fraud.

Insofar as is permitted by law, the Promoter, its partners, agents or distributors (including YinzCam) will not in any circumstances be responsible or liable to compensate any winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the Prize except where it is caused by the negligence of the Promoter, its partners, agents or distributors or that of their employees. Your statutory rights are not affected.
