We are also organising Nerve Health Diagnostic camps across India in coming weeks to help consumers #TestTheSigns of Peripheral Neuropathy and Vitamin B Deficiency"

With Diabetes Mellitus Type 2 being the leading cause<sup>1</sup> of PN, the increasing prevalence of PN is closely linked to the rise in the number of diabetic patients. Diabetic Peripheral Neuropathy (DPN) is the result of damage to the nerves impacting quality of life of people as they are not able to go about their daily lives as comfortably. Symptoms of PN include numbness, tingling, prickling, and burning sensations in the hands and feet. B vitamin deficiency and polymedication are other high-risk factors along with diabetes, leading to peripheral nerve damage. Published studies across different countries confirm that up to 80% of patients with PN remain undiagnosed and untreated.
