

Conditions of Purchase

Status: October 01, 2025

1. Order and Confirmation of Order

- 1.1 These General Conditions of Purchase establish the conditions for the contracting of products and services by Siemens, S.A. with Tax Identification Code A-28006377, Street Ronda de Europa 5, C.P. 28760 Tres Cantos (Madrid) (hereinafter, the "Customer").
- 1.2 Once the Customer has placed the order, the Customer may cancel the order if the Supplier has not confirmed acceptance of the order (confirmation) in writing within two weeks of receipt it.
- 1.3 Any alterations, amendments or additions to the order shall only become a part of the agreement if the Customer accepts expressly such in writing. In the event that the Customer accepts any deviation from these General Terms and Conditions, it shall only apply to the specific contract/order for which such exception is accepted and in no case shall it mean that it shall apply to any previous order that is in force or to any other order/contract that may be entered into in the future. The acceptance of deliveries or services as well as payments does not constitute conformity of them until expressly notified by the Customer.
- 1.4 Any provisions in other documents (such as but not limited to specifications, data sheets, technical documentation, advertising materials, order confirmation and/or shipping documents) regarding legal terms, warranty, liability, restriction of use, restriction of application and/or restriction of suitability, or any other provision that changes the provisions of these Conditions of Purchase shall not be applicable, unless previously accepted in writing by the Customer.
- 1.5 In the event that the subject matter of the contract is works and services, the Siemens General Conditions of Subcontracting shall apply in addition to the present terms and conditions.

2. Rights of Use

- 2.1 The Supplier hereby grants the Customer the following non-exclusive, transferable, worldwide and perpetual rights:
 - 2.1.1 to use the deliveries and services including any output created by using artificial intelligence and related documentation, to integrate them into other products and to distribute them.
 - 2.1.2 to install, launch, test and operate software and its related documentation (hereinafter collectively referred to as "Software").
 - 2.1.3 to sublicense the right of use under section 2.1.2 above to affiliates (as defined by the article 42 of the Spanish Commerce Code), to contracted third parties, to distributors and to end customers;
 - 2.1.4 to license to affiliates (as defined by the article 42 of the Spanish Commerce Code), and other distributors the right to sublicense the right of use under section 2.1.2 above to end customers;
 - 2.1.5 to use the Software for integration into other products and to copy the Software, or to allow affiliates (as defined by the article 42 of the Spanish Commerce Code), contracted third parties or distributors to use and copy the Software;
 - 2.1.6 to distribute, sell, hire out, lease, make ready for download or make publicly available the Software, e.g. in the context of application service providing or in other contexts, and to copy the Software to the extent required, always provided that the number of licenses being used at any one time does not exceed the number of licenses purchased;
 - 2.1.7 to sublicense the right of use under section 2.1.6 above to affiliates (as defined by the article 42 of the Spanish Commerce Code), contracted third parties and distributors.
 - 2.1.8 The use rights granted in section 2.1 include the use of deliveries and services, including any output thereof, for the purpose of training of artificial intelligence
- 2.2 In addition to the rights granted in section 2.1 above, the Customer, affiliates (as defined by the article 42 of the Spanish Commerce Code) and distributors are authorized to allow end customers to transfer the respective licenses.
- 2.3 All sublicenses granted by the Customer shall contain appropriate protection for the intellectual property rights of the Supplier in the Software. All sublicenses shall contain any contractual provisions used by the Customer to protect its own intellectual property rights.
- 2.4 The Supplier shall inform the Customer - at the latest at the time the contract is concluded - whether the products and services to be delivered contain open source software (OSS) components.

In the context of this provision "OSS components" means any software, hardware or other information that is provided royalty-free by the respective licensor to any user on the basis of a license with the right to modify and/or to distribute (e.g. GNU General Public License (GPL), or the MIT License). Should the products and services delivered by the Supplier contain OSS components, the Supplier shall comply with all

applicable OSS license terms and shall grant all those rights to the Customer and provide all information which the Customer needs in order to comply himself with the applicable license terms. In particular, the Supplier shall deliver to the Customer promptly after the contract is concluded following:

- A schedule of all OSS components used including their versions, indicating the relevant licenses, including a copy of the complete text of such licenses copyright and/or authorship notices.
- The source code of the relevant open OSS, including scripts and information regarding its generating environment insofar as the applicable OSS conditions require this.

- 2.5 The Supplier shall by the time of contract conclusion at the latest inform the Customer in writing whether any OSS licenses used by the Supplier might be subject to a Copyleft Effect which could affect the products of the Customer. In the context of this provision, "Copyleft Effect" means that the provisions of the OSS license require that certain of the Supplier's products, as well as any products derived from such products, may only be redistributed in accordance with the terms of the OSS license, e.g. only if the source code is disclosed. In case any OSS licenses used by the Supplier are subject to a "Copyleft Effect" as defined above, then the Customer is entitled to cancel the order within two weeks of receipt of this information.

3. Term and Penalty for Breach

- 3.1 Delivery times shall be those indicated in the specific order/contract and are considered an essential obligation to be fulfilled by the Supplier. For the purposes of establishing the timeliness of delivery, unless otherwise specifically stated in the order/contract, the relevant point in time is the date of receipt at the place of destination/delivery according to Incoterms ® 2020 designated by the Customer, and for deliveries involving installation, commissioning or rectification services, the relevant point in time shall be the date of acceptance by the Customer or, as the case may be, of the Final Customer (Final Customer shall mean the customer of the Customer).
 - 3.2 If any delay in delivery or performance or rectification is anticipated, the Customer shall be notified immediately and its decision sought.
 - 3.3 If – in the event of delay – the Supplier cannot prove that it is not responsible for the delay, the Customer may charge a penalty in respect of each commenced working day of delay amounting to 0.3 % (zero point three percent) but not exceeding a total of 10 % (ten percent) of the total value of the contract, unless other different penalties are indicated in the Order/Contract. The above penalties do not exclude or limit the Customer's right to request to the Supplier to fulfill its contractual obligations and claim a compensation of damages to which the Customer may be entitled as a result of any failure of the Supplier.
 - 3.4 Additional or other statutory rights are not affected by the present conditions nor limited by what is indicated in the present clause. The amount of the penalties may be deducted directly from the Customer's outstanding invoices with the Supplier.

4. Transfer of Risk, Dispatch and Place of Performance, Transfer of Title

- 4.1 For deliveries involving installation, commissioning or services, the transfer of risk occurs on acceptance by the Customer and for deliveries not involving installation or commissioning, the transfer of risk shall be upon receipt by the Customer or Final Customer at the named place of destination/delivery according to Incoterms ® 2020 and the Client accepts them. Unless agreed otherwise, DDP (named place of destination) Incoterms ® 2020 shall apply, if (a) the seat of the Supplier and the named place of destination are within the same country or if (b) the seat of the Supplier and the named place of destination are both within the European Union. If neither (a) nor (b) are fulfilled, then DAP (named place of destination) Incoterms ® 2020 shall apply, unless agreed otherwise. Deliveries and services shall be performed at the risk and expense of the Supplier, and the economic result shall be for the sole account of the Supplier. The Supplier shall deliver the products and perform the services in strict compliance with the applicable laws and regulations, the Contract or Order, the contractual documentation and all instructions received from the Customer.
- 4.2 Unless otherwise agreed in writing, the costs of adequate packaging shall be borne by the Supplier. In case transportation costs are borne by the Customer, notice of readiness for dispatch shall be given together with the information set out in section 4.3 hereunder. On Customer's request routing order tool must be used by the Supplier. Transport shall be at the lowest possible cost, insofar as the Customer

has not requested a particular method of delivery or the conclusion of the contract for carriage by the Customer. Any supplementary costs arising from non-conformity with the transport requirements including costs arising from the non-application of the Siemens routing order tool shall be borne by the Supplier. In case DAP/DDP (named place of destination) Incoterms® 2020 is agreed, the Customer may also determine the method of transportation. Any supplementary costs arising from the need to meet the delivery deadline by way of expedited delivery shall be borne by the Supplier.

- 4.3 Each delivery shall include a packing note or delivery note with details of the contents as well as the complete order number.
- 4.4 As far as the Customer and the Supplier agree that the Supplier orders the transport of deliveries containing dangerous goods for account of the Customer, the Supplier is responsible to transfer the necessary legally required dangerous goods data to the freight forwarder nominated by the Customer when placing the transport order. The Supplier is in these cases also responsible for packing, marking, labelling etc. in compliance with the regulation relevant to the mode(s) of transport used.
- 4.5 If the Customer informs the Supplier that following the initial transport another transport with a different mode of transport is scheduled, the Supplier will also follow the relevant legal requirements concerning dangerous goods with regard to such on-going transport.
- 4.6 Transfer of title shall be upon delivery or acceptance by the Customer, as the case may be.

5. Payment, Invoices

- 5.1 Unless otherwise agreed, payments shall be due and payable no later than 60 (sixty) days net. If payment is made within 14 (fourteen) days, the Customer is entitled to a 3 % (three percent) discount provided that prompt payment is agreed in advance with the Supplier. The period for payment shall commence as soon as any delivery or service is completed and a correctly issued invoice is received. The Customer may make partial payments.
- 5.2 The order number as well as the number of each individual item shall be detailed in invoices as well as any legal requirements that may be required under the legislation in force from time to time. Insofar as any such details are omitted, invoices shall not be payable. Copies of invoices shall be marked as duplicates.
- 5.3 Insofar as the Supplier is required to provide material testing, test records or quality control documents or any other documentation, such shall be a part of the requirements of the completeness of the delivery or performance.
- 5.4 Payment does not constitute an acknowledgement that the corresponding delivery or services were provided in accordance with the contract/order.

The prices are fixed and invariable and may not be subject to modification or variation, except by mutual written agreement between the Parties. Furthermore, the agreed price includes everything necessary for the correct execution of the work and delivery of supplies.

The Client shall have the right to suspend payment of any amount in the event that:

- a) the Supplier fails to fulfil any obligations set out in the Order, Contract and/or in these General Conditions of Purchase.
- b) In the event that the Customer receives a communication from a third party in relation to a possible breach by the Supplier.
- c) In the event that the Customer is not provided with proof of being up to date with Social Security and Tax Office payments, if applicable.
- d) In the event that the Client becomes aware of any possible non-compliance by the Supplier for which the Client may be jointly and severally liable.
- e) In the event of non-compliance with health and safety measures for workers, if applicable.

6. Inspection upon receipt

- 6.1 The Customer shall upon receipt at the named place of destination examine whether a delivery corresponds to the quantity and type of products ordered and whether there are any external recognizable transportation damage or other obvious defects.
- 6.2 Should the Customer discover any deficiency in the course of these inspections or at any later stage, it shall inform the Supplier of such defects and the Supplier shall remedy it. In this regard the Customer shall have no other duties to the Supplier other than the duties of inspection and notification above.

7. Warranty

- 7.1 If defects are identified before or during the transfer of risk or during the warranty period provided for in section 7.7 or 7.8, the Supplier shall at its own expense and at the discretion of the Customer either repair the defect or provide re-performance of services or replacement of

deliveries (= rectification). This provision also applies to deliveries subject to inspection by sample tests. The discretion of the Customer shall be exercised fairly and reasonably.

- 7.2 Should the Supplier fail to rectify (i.e. repair or replacement) any defect within a reasonable time period set by the Customer, the Customer is entitled to:

7.2.1 cancel the contract/order in whole or in part without being subject to any liability for damages; or

7.2.2 demand a reduction in price; or

7.2.3 undertake itself any repair at the expense of the Supplier or reperformance of services or replacement of deliveries or arrange for such to be done who shall bear all costs and expenses arising therefrom; and

7.2.4 claim damages caused by such non-compliance.

For the purpose of establishing that the Supplier has remedied/rectified the defect indicated, the timeliness of the rectification, the relevant point in time in the case of supplies shall be deemed to have been remedied when the Supplier delivers the supplies is the date of receipt at the place of destination and provided that the supplies have been delivered correctly and it has been verified by the Customer that the defects have been remedied. In the case of services and work, rectification/rectification shall be deemed to have taken place once the Supplier has carried out the rectification work and the Customer has verified that it has been correctly rectified.

- 7.3 The rights according to 7.2 may be exercised immediately if the Customer has a strong particular interest in immediate rectification in order to avoid any liability of its own for delay or for other reasons of urgency.

- 7.4 Additional or other statutory rights are not affected hereby.

- 7.5 If the Supplier provides subsequent performance or repairs, the warranty periods set out in section 7.7 and 7.8 shall begin to run once again.

- 7.6 Notwithstanding the transfer of risk regarding delivery, the Supplier shall bear all the costs and risk related to the rectification (e.g. return costs, costs of transport, costs of de- and re-installation).

- 7.7 The warranty period for defects of material and for services/works is three years from the date of acceptance by the Client and/or the End Client, insofar as no statutory provisions provide longer periods.

- 7.8 The warranty period for defects of title is five years, insofar as no statutory provisions provide longer periods.

- 7.9 For deliveries not involving installation or commissioning, the warranty period begins to run with the acceptance by the Customer which shall not be delayed and shall not be more than 30 days from receipt of them. For deliveries involving installation, commissioning or services, the warranty period begins to run with acceptance by the Customer. Upon delivery to locations where the Customer is operating outside its premises, the warranty period begins with the acceptance by the End Customer.

8. Supplier's Duty to Verify and to Inform

- 8.1 The Supplier is obliged to examine components such as, e.g., raw material, provided by the Customer or provided by Supplier's suppliers, manufacturers or other third parties at the time of receipt of such components as to whether these components show any obvious or hidden defects. In case any defects are discovered in the course of such inspections, the Supplier shall immediately inform its suppliers or – in the case the components are provided by the Customer – inform the Customer.

- 8.2 It is essential that the products are delivered free of any third party rights. Thus the Supplier is under a duty to verify title and inform the Customer of any possible conflicting industrial and intellectual property rights or any other. Any breach of such duty is subject to the normal statutory limitation period.

9. Subcontracting to Third Parties

- 9.1 The Supplier shall maintain a quality management system (e.g. according to DIN EN ISO 9001).

- 9.2 Subcontracting to third parties shall not take place without the prior written consent of the Customer and entitles the Customer to cancel the contract in whole or in part and claim damages. Subcontracting does not create any form of contractual relationship between the Client and the Supplier's Subcontractors. Subcontracting does not absolve the Supplier from any of its contractual responsibilities or obligations; rather, it assumes responsibility for the actions of its Subcontractors. In the event that the Supplier fails to pay the subcontractors, the Customer may withhold invoices and payments due to the Supplier and pay those amounts to the subcontractors directly.

10. Provided Material

- 10.1 Material provided by the Customer remains the property of the Customer and is to be stored, labeled as property of the Customer and

- administered separately at no cost to the Customer. Their use is limited to the orders of the Customer only. The Supplier shall supply replacements in the event of reduction of value or loss, for which the Supplier is responsible, even in the event of simple negligence. This also applies to the transfer of allocated material.
- 10.2 Any processing or transformation of the material shall take place for the Customer. The Customer shall immediately become owner of the new or transformed product. Should this be impossible for legal reasons, the Customer and the Supplier hereby agree that the Customer shall be the owner of the new product at all times during the processing or transformation. The Supplier shall keep the new product safe for the Customer at no extra cost and in so doing exercise the duty of care of a merchant.
- 11. Tools, Patterns, Samples, Confidentiality**
- 11.1 Any tools, patterns, samples, models, profiles, drawings, standard specification sheets, printing templates and materials provided by the Customer, any input when using artificial intelligence, as well as any materials or output derived there from, shall not be made available to any third party nor used for any other purpose than those contractually agreed except with the prior written consent of the Customer. Such materials shall be protected against unauthorized access or use. Subject to any further rights the Customer may demand that such materials be returned if the Supplier breaches these duties.
- 11.2 The Supplier shall treat as confidential the knowledge and findings, documents, data, terms of reference, business processes or other information that it receives from or about the Customer in the context of performing the deliveries and services, as well as the conclusion of the contract and any results, with regard to third parties - and shall keep the same confidential beyond the term of the contract - for as long as and insofar as such information has not become publicly known by legal means or the Customer has not consented in writing to its transfer in the individual case. The Supplier shall use this information exclusively for the purpose of performing the deliveries and services. Insofar as the Customer agrees to any subcontracting to a third party, such third party shall agree to such terms in writing than those accepted by the Supplier.
- 12. Assignment of Claims**
- Any assignment of any claim is only allowed with the prior written approval of the Customer. The Customer may entirely or partly assign the Order to any of its Affiliates and - in connection with any type of merger, consolidation, divestiture, dissolution and any other type of business combination or business reorganization, including, without limitation, the establishment of joint venture companies - to any third party
- 13. Right to Terminate and Cancel**
- 13.1 In addition to any rights provided by law to withdraw from or cancel a contract, the Customer may cancel the contract in whole or in part in case
- 13.2 (a) the Supplier is in delay with its delivery or service.
- 13.3 (b) The Customer cannot reasonably be expected to perform the contract with its End Customer for reasons attributable to the Supplier and taking into account the circumstances of the case and the interests of both parties. This might, for example, apply in case of an actual or possible deterioration of Supplier's financial situation thus threatening the due fulfillment of Supplier's obligations under the contract.
- c) The Supplier fails to comply with any of its Tax or Social Security obligations.
- d) The Supplier fails to comply with any basic provisions of the contract or with these General Conditions.
- e) breach, the health and safety at work obligations
- f) In the event that the contract between the Customer and End Customer is terminated or canceled.
- g) If the Supplier subcontracts, in whole or in part, without the express approval of the Customer.
- h) In the event of suspension of the execution of the service for any reason for a period of more than 3 months, including strikes.
- i) In the event that the Supplier fails to commence work on the agreed date.
- In cases in which the Contract is terminated for reasons attributable to the Supplier, the Customer shall retain all rights over the defaulting party and may claim for damages as a result. Furthermore, once the Supplier has received the notice of termination, it shall cease all work or activity and shall return and/or hand over to the Customer all documents, information and any other material in its possession relating to the supplies and/or services covered by the Order.
- 13.4 Furthermore, the Customer may terminate the contract early, for any reason whatsoever, by sending a letter by registered post or other reliable means to the Supplier with a 60-day notice of termination in advance of the date it intends to terminate the contract. In this scenario, the Supplier shall be entitled only to payment for services rendered until the day the Contract is set to be terminated.
- 13.5 In case of a termination by the Customer the Customer may continue to utilize existing facilities, deliveries or services already performed by the Supplier in exchange for reasonable payment.
- 14. Code of Conduct for Siemens Suppliers, Security in the Supply Chain, Cartel Damages**
- 14.1 The Supplier is obliged to comply with the laws of the applicable legal system(s). In particular, the Supplier will not engage, actively or passively, nor directly or indirectly in any form of bribery, in any violation of basic human rights of employees or any child labor. Moreover, the Supplier will take responsibility for the health and safety of its employees and will act in accordance with the applicable environmental laws. The Supplier will take adequate measures to avoid the deployment of so-called conflict minerals and to create transparency over the origin of raw materials, and will use best efforts to promote this Code of Conduct among its suppliers.
- 14.2 The Supplier shall strongly support the efforts of the Customer regarding security in the supply chain, which includes the attainment and preservation of the status as an Authorized Economic Operator (AEO) in terms of WCO SAFE Framework of Standards. Upon request of the Customer, the Supplier shall without undue delay sign and return to the Customer a written declaration on security in the supply chain provided by the Customer, which will be consistent with - depending on the registered office of the Supplier - the requirements of the European Commission according to the then current AEO Guidelines or the requirements of a comparable initiative for security in the supply chain according to WCO SAFE Framework of Standards (e.g. C-TPAT), unless the Supplier itself owns the status of AEO or a comparable status based on WCO SAFE Framework of Standards and is able to demonstrate such by providing an authorization or certificate respectively.
- 14.3 In addition to other rights and remedies the Customer may have, the Customer may terminate the contract in case of breach of the obligations under section 14 by the Supplier. However, provided that the Supplier's breach of contract is capable of remedy, the Customer's right to terminate is subject to the proviso that such breach has not been remedied by the Supplier within a reasonable grace period set by the Customer.
- 14.4 If the Supplier violates applicable antitrust laws, by forming a cartel or by a similar anticompetitive behavior, in relation to the deliveries and services supplied to the Customer, the Supplier shall pay to the Customer liquidated damages in the amount of 15% (fifteen percent) of the total remuneration for the relevant deliveries and services during the relevant period.
- 14.5 Notwithstanding section 14.4, both parties shall be entitled to prove that the Customer's actual damages are higher or lower than the liquidated damages amount, in which case such actual damages shall be payable pursuant hereto. All other contractual or statutory rights and claims of the Customer remain unaffected
- 15. Product Conformity, Product Related Environmental Protection including Substance Declaration, Dangerous Goods, Occupational Health and Safety**
- 15.1 Should the deliveries of the Supplier contain products, including their packaging and Software, to which product-related statutory and legal requirements apply in view of their further marketing in the European Economic Area, then the Supplier shall ensure compliance of the products with these requirements at the time of transfer of risk and shall fulfil all pertinent legal obligations placed on the Supplier as an (economic) operator. The same applies for corresponding requirements and obligations in other countries notified by the Customer to the Supplier by the time of conclusion of the contract. Upon request, the Supplier shall immediately provide the Customer with all documents and information which may be necessary to demonstrate or maintain the conformity of products with the respective requirements or for product registration purposes, inquiries or audit.
- 15.2 In the web database BOMcheck (www.BOMcheck.net), the Supplier shall provide and maintain up-to-date information as requested and declare whether or not substances contained in the products:
- 15.2.1 are, at the time of delivery, set out in the latest List of Restricted and Declarable Substances of BOMcheck (<https://docs.bomcheck.com/en/resources/substances>) or another list as notified by the Customer sufficiently in advance; and
- 15.2.2 are subject to substance restrictions and/or information requirements imposed by law applicable at: (i) the registered seat of the Supplier, or (ii) the registered seat of the Customer, or (iii) the place of delivery designated by the Customer. The Supplier shall provide this information as soon as possible but no later than the product delivery.

- 15.3 Should the delivery contain goods which – according to international regulations – are classified as dangerous goods, the Supplier will inform the Customer hereof in a form agreed upon between the Supplier and the Customer, but in no case later than the date of contract conclusion. The requirements concerning dangerous goods in section 4.4 and 4.5 remain unaffected.
- 15.4 The Supplier is obliged to comply with all legal requirements regarding the health and safety of the personnel employed by the Supplier. It shall ensure that the health and safety of its personnel as well as indirect subcontractors employed to perform the deliveries and services is protected.
- 16. Cybersecurity Clause**
- 16.1 The Supplier shall take appropriate organizational and technical measures to ensure the confidentiality, authenticity, integrity and availability of Supplier Operations as well as products and services. These measures shall be consistent with applicable laws, regulations and good industry practice and shall include an appropriate information security management system consistent with standards such as ISO/IEC 27001 or IEC 62443 (to the extent applicable).
- 16.2 "Supplier Operations" means all assets, processes and systems (including information systems), data (including Customer data), personnel, and sites, used or processed by Supplier from time to time in the performance of this Agreement.
- 16.3 Should products or services contain Software, firmware, chipsets, or integrated circuits or generic functional blocks ("Digital Products"):
- 16.3.1. Supplier shall comply with safe and secure, state-of-the-art development methods including secure coding standards (, such as, OWASP standards, NIST Secure Software Development Framework SP800-218 or similar), equivalence checks, code re-views, and threat and risk analysis.
- 16.3.2. Supplier shall ensure that Digital Products shall be designed, developed and produced in such a way that they ensure an appropriate level of cybersecurity based on the risks, including the minimization of negative impact on the availability on other products, connected devices or services. Further, Supplier shall ensure that Digital Products are made available with a secure-by-default configuration (incl. secure data transfer, the possibility to reset to the original state with the secure and permanent removal of all data and settings);
- 16.3.3. Supplier shall ensure that Digital Products provide security related information by recording and monitoring relevant internal activity, including the access to or modification of data, services or functions, with an option to disable this feature;
- 16.3.4 During the whole lifecycle of a Digital Product (including but not limited to design, development, production, delivery and maintenance) Supplier shall implement and maintain appropriate standards, processes and methods to prevent, identify, evaluate and repair any vulnerabilities, malicious code, and security incidents in the Digital Product. Such measures shall be consistent with good industry practice and standards such as ISO/IEC 27001 or IEC 62443 (to the extent applicable);
- 16.3.5. the Supplier shall continue to support and provide services to repair, update, upgrade and maintain Digital Products including the provision of patches to Customer remedying vulnerabilities and other cybersecurity risks for the expected use time of the Digital for the expected use time of the Digital Products;
- 16.3.6. the Supplier shall provide to Customer a software bill of materials in a commonly used and machine-readable format (e.g., CycloneDX version ≥ 1.4 or equivalent) to the following address: sbom.cys@siemens.com, and a bill of materials, both identifying Digital Products including all third-party Digital Products. The Digital Products shall contain all necessary security updates at the time of delivery to Customer;
- 16.3.7. Supplier shall grant Customer the right, Customer shall not be obliged, to test or have tested products for malicious code and vulnerabilities at any time, and shall adequately support Customer;
- 16.3.8. Upon request of Customer, Supplier shall promptly provide to Customer all documents and information which are necessary to demonstrate the conformity of Digital Products .
- 16.3.9. For integrity reasons, Supplier shall ensure that all software-related components provided to Customer are digitally signed. If Supplier fails to provide a signed version and does not remediate this within a reasonable time frame set by Customer, Customer may digitally sign these components itself independently of Supplier. Any warranty rights Customer may have remain unaffected by this provision.
- 16.4 Supplier shall provide Customer a contact for all cybersecurity-related issues (available during business hours).
- 16.5 The Supplier shall promptly, and in a structured and machine-readable format notify Customer and the following Siemens Cybersecurity contact addresses of all relevant cyber threats incidents occurred or suspected and vulnerabilities discovered and/or actively exploited in any Supplier Operations, services and products, if and to the extent Customer is or is likely to be materially affected.
- 16.5.1. for security incidents: cert@siemens.com;
- 16.5.2. for cyber threats and security vulnerabilities: svm.ct@siemens.com
- The notification shall contain any information reasonably required to assess the impact and to enable Customer to comply with its statutory obligations.
- The notification shall be made before any public disclosure of fixed vulnerabilities, allowing Customer reasonable time to implement security updates or remediation measures
- 16.6 Supplier shall take appropriate measures to achieve that its subcontractors and suppliers shall, within a reasonable time, be bound by obligations similar to the provisions of this section 16.
- 16.7 Upon Customer's request, Supplier shall provide written evidence of its compliance with this section 16 including generally accepted audit reports (e.g., SSAE-16 SOC 2 Type II).
- 17. Export Control and Foreign Trade Data Regulations**
- 17.1 Supplier shall comply with all applicable export and import restrictions, customs and foreign trade regulations (hereinafter referred to as "Foreign Trade Regulations") in relation to all deliveries and services to be provided according to this contract. The Supplier shall obtain all necessary export licenses pursuant to the applicable Foreign Trade Regulations. . In particular, the Supplier represents and warrants that none of its deliveries nor its services provided under the contract contain prohibited products and/or services under the Foreign Trade Regulations applicable to the Customer (including, but not limited to, Council Regulations (EU) 833/2014, 692/2014, 2022/263 or 765/2006 as well as the U.S. Export Administration Regulations (15 C.F.R. Parts 730-774), and import regulations enforced by U.S. Customs and Border Protection
- 17.2 The Supplier shall advise the Customer in writing within two weeks of receipt of the order and in any case before delivery - and in case of any changes without undue delay - of any information and data required by the Customer to comply with all Foreign Trade Regulations in case of export and import as well as re-export, including without limitation:
- all applicable export list numbers, including the Export Control Classification Number according to the U.S. Commerce Control List (ECCN); and
 - the statistical commodity code according to the current commodity classification for foreign trade statistics and the HS (Harmonized System) coding; and
 - the country of origin (non-preferential origin); and - upon request of the Customer- documents to prove the non-preferential origin; and
 - the preferential country of origin, and, upon request of the Customer, documents pursuant to the requirements of the applicable preferential law to prove the preferential origin (e.g. supplier's declaration)
- 18. Reservation Clause**
- The Customer shall not be obligated to fulfill the contract if such fulfillment is prevented by any impediments arising out of national or international foreign trade or customs requirements or any embargoes or other sanctions.
- 19. Mention as Reference Customer**
- Only upon the Customer's prior written approval, the Supplier shall be allowed to mention the Customer as a reference customer and/or make reference to products or services which the Supplier has developed during the performance of an order for the Customer.

20. Requirement for information concerning supplies/non-reusable plastic packaging in deliveries (protective films, straps, blister packs, air cushions, etc).

Suppliers must provide Siemens the information indicated below in order to comply with Spanish Law 7/2022 of 8 April "On waste and contaminated soils for a circular economy" (hereinafter, the Law) which introduces the requirement to declare the "Special tax on non-reusable plastic packages", starting from 1 January 2023.

This tax applies to imports and intra-Community acquisitions within the European Union, as well as the manufacturing of the following products: packages and containers that contain non-reused plastic. We inform you that, in accordance with the Law, the products supplied from Spain are not subject to this Law and the corresponding tax.

To comply with the Law and the obligations arising from the declaration of the aforementioned tax, suppliers must provide the following information in due time and form:

- a) For deliveries from a non-EU country and for deliveries from an EU country with destination in the Canary Islands, Ceuta or Melilla (for which the corresponding export and import customs clearances must also be made, respectively), the following information must be included in the delivery note or invoice (regardless of its format):
 - kg of non-reusable plastic packages or containers;
 - in the event that these packages or containers contain recycled plastic, this amount must be informed, and an official certificate must be provided that accredits this circumstance.
- b) For deliveries from an EU country, the following information must be included in the delivery note (regardless of its format):
 - kg of non-reusable plastic packages or containers;
 - in the event that these packages or containers contain recycled plastic, this amount must be informed, and an official certificate must be provided that accredits this circumstance.

21. Antitrust

If the Supplier violates applicable antitrust laws, by forming a cartel or by a similar anticompetitive behavior, in relation to the deliveries and services supplied to the Customer, the Supplier shall pay to the Customer a penalty of 15% of the total remuneration for the relevant deliveries and services during the relevant period. Notwithstanding the immediately preceding sentence, both parties shall be entitled to prove that the Customer's actual damages are higher or lower than the liquidated damages amount, in which case such actual damages shall be payable pursuant hereto. All other contractual or statutory rights and claims of the Customer, including the compensation for damages, remain unaffected

22. Supplementary Provisions

In all matters not regulated in these Conditions of Purchase, the provisions of Spanish law shall apply.

- 22.1 The Supplier shall be liable for any expenses and/or damages incurred by the Customer due to any breach of these conditions, in particular of sections 2, 3, 4, 7, 8, 14, 15, 16 and 17, unless the Supplier is not responsible for such breach. The expenses required for the rectification of any defect shall be borne by the Supplier irrespective of whether the Supplier is responsible for fault or not.
- 22.2 Unless there are justified problems on the part of the supplier, the supplier will incorporate and use the transmission solutions and will incorporate, in particular, efficient electronic purchase order transmission solutions based on electronic data interchange (EDI), either directly with the Customer, the respective purchase order transmission entity or via a digital supply chain service provider (such as SupplyOn AG). The Supplier shall comply with the provisions relating to EDI as modified by any Approval Agreement and shall comply with any other requirements imposed in this respect.
- 22.3 Notices of termination of the Order/Contract as well as any modification thereof (including any waiver of the written form requirement), shall be in writing or by electronic signature, using an electronic signature software tool.
- 22.4 The Supplier shall actively support the e-commerce strategies and processes initiated by the Customer.

23. Protection of Personal Data

The personal data belonging to the Supplier, provided that it is a physical person, or its representatives or persons with whom they have a professional relationship, will be incorporated into a Siemens SA file, with address at 5, Ronda de Europa, Tres Cantos, Madrid, Spain. The purpose of the processing shall be to respond to questions and meet

the obligations of the legal relationship that is intended to be created or that exists between the parties; and legitimisation shall be that of their own consent or that of the preparation or execution of the contract, respectively. The prospective offer of products and services is based on the consent that is requested, with the withdrawal of this consent under no circumstances conditioning the execution of the contract referred to. The data shall be stored until the purpose described is fulfilled, and for the legally established amount of time, which, in terms of the prevention of money laundering, may be extended for up to 10 years.

24. Confidentiality

Both parties undertake to maintain absolute confidentiality regarding the content and execution of the agreements contained in the contract herein during its validity and after the expiration thereof, and to not use or communicate to third parties any trade secrets, industrial secrets or any other knowledge that it has obtained as a result of this contract, including its terms and conditions

25. Place of Jurisdiction and Applicable Law

Spanish substantive law shall apply, excluding the provisions of the United Nations Law on the Sale of Goods of 11th of April 1980.

The court of jurisdiction shall be Madrid.
