In the time period from 10 March 2025 until and including 16 March 2025 a number of 157,264 shares were bought back within the framework of the share buyback of Siemens Aktiengesellschaft; on 12 February 2024, Siemens Aktiengesellschaft disclosed pursuant to art. 5 para. 1 lit. a) of the Regulation (EU) no. 596/2014 and art. 2 para. 1 of the Delegated Regulation (EU) no. 2016/1052 the begin of the share buyback on 12 February 2024.
