



## Win 3x Your Salary with Your ila Current Account

### 1- Campaign periods:

The campaign runs until 15/09/2026.

### 2- Campaign Terms & Conditions

- The campaign is eligible to all existing and new ila customers.
- To qualify for the prize draw customers must transfer their salary into their "ila" current account, with a minimum monthly amount of 400 Jordanian Dinars.
- The eligible customers must:
  - Have an active "ila" account in their name.
  - Be a resident of Jordan.
  - Transfer the salary to their "ila" account every month during the campaign period.
  - Transfer the salary to the "ila" account for at least two (2) consecutive months during the campaign period.
  - Transfer the salary through official transfer channels only—cash deposits or manual transfers are not eligible.
  - Be employed full-time with a registered company or institution and subscribed with the Social Security Corporation.
- The winner must continue transferring their salary for at least 12 months after receiving the prize.
- The winner must provide an official letter from their employer confirming the salary transfer to their "ila" current account, along with an official letter from the Social Security Corporation, within a maximum of two months.
- The prize amount will be calculated based on the average of the last two (2) salaries received in "ila" current account.
- The prize value will be deposited into the winner's "ila" current account.
- If a selected winner does not meet the eligibility criteria, a re-draw will be conducted.
- Any misuse or detected fraudulent activity will result in immediate disqualification from the campaign.



- The winning customer must visit the bank within five working days from the date they are notified of winning, whether by a phone call or by email from the bank, in order to complete the prize collection procedures.
- Prize collection requires providing the bank with all required documents and paperwork as specified by the bank in the campaign's terms and conditions. These include:
  - An official letter issued by the employer confirming that the salary is transferred to the current account in "Ila,"
  - A commitment letter to continue transferring the salary to the bank,
  - The salary slips issued by the employer for the last two months prior to the winning date,
  - A detailed salary statement issued by the Social Security Corporation for the last two months prior to the winning date.
- If the winning customer does not visit the bank to receive the prize and/or does not provide the required documents within 5 working days from the date they were notified of winning, this will be considered an implicit waiver of the prize. The customer will be deemed ineligible for the prize and will permanently lose any right to claim it in the future in any form whatsoever. The bank shall bear no legal, financial, or compensatory responsibility resulting from the customer's failure to collect the prize within the specified period.
- The winners shall approve and take part in announcements related to the campaign including having his/her picture taken and enclosing their names
- Bank ABC employees, and employees of the Arab Cooperation Company for Financial Investments ABCI are not eligible to participate in the draw.
- The customer must not be listed on the blacklists of Bank ABC or the Central Bank of Jordan.
- The winners shall be excluded from future Salary Transfer Campaigns for a full year as of the date of winning by the same customer and/or as per the product conditions announced by ila.
- A tax rate of 15% will be deducted from the prize value if it exceeds 999 Jordanian Dinars.
