

OFFICIAL SWEEPSTAKES RULES

Void outside the Continental United States, where prohibited, and in the following states: Florida and New York. Do not proceed to enter if you are not at least eighteen (18) years of age and a legal resident of, and located within, the Continental United States at the time of entry. Do not proceed to enter if you are a legal resident of Florida or New York. By participating, you agree to be bound by these Official Sweepstakes Rules and the decisions of the Sponsor (as defined below), which are binding and final on matters relating to this sweepstakes (“Sweepstakes”).
