# Weekly Market Report

## Week Ending November 28th



### Summary - Week Ending November 28th

Note: Current market performance will now be compared to 2020 and 2019 to provide a clear perspective on this year's activity against last year's COVID-affected market.

>New listing volume saw a similar week-over-week Thanksgiving decline as the prior two years. However, activity tracked at 81.9% of '20 and was up marginally from '19 at 104.3%.

> This week saw a larger new purchase contract to new listing ratio due to new listings seeing a seasonal week of Thanksgiving decline.

➢End of month closing volume tracked lower than the week of Thanksgiving in both '20 and '19 (95.7% of '20 and 97.5% of '19).

>While showing volume fell compared to the week of Thanksgiving in '20 (81.8%), it gained versus '19 (104.3%). Average weekly showings over last month (85,275) dipped -2.4% from the same period a year ago.




### New Purchase Contract to New Listing Ratio

### **Active New Listings**


• For the week of Thanksgiving this week, total available inventory tracked at 104.2% of the same week a year ago but landed at 79.2% of 2019 levels.



### Weekly New Closed Listings

•For the final week of November, closing volume tracked below Thanksgiving weeks for 2020 and 2019 (95.7% and 97.5% respectively).


•DE (112.5% of '20, 114.7% of '19) and VA (101.9% of '20, 109.3% of '19) lead activity during the week.



### **Weekly New Listings**

• Thanksgiving week-to-week declines (-41.3%) were slightly elevated compared to the year prior (-33.5%).


•Against yearly benchmarks, activity tracked at 84.2% of 2020 and 103.8% of '19. WV showed strength against both 2020 and 2019 (114.8% of '20 and 189.2% of '19).

### Weekly New Purchase Contracts

•Activity was marginally below the '20 market (94.3%), but up from '19 (126.3%). VA (99.4% vs '20 and 133.5% vs '19) had notable results for the week.



• The number of days from contract to closing (41) was four days less than 2020 and 2019.



### **Weekly Showing Activity**

•Weekly showing volume tracked lower compared to the week of Thanksgiving in 2020 (81.8%) but saw a slight gain compared to '19 (104.3%).

• Over the past month, the avg. number of showings per week came in at 85,275 which was 2.4% lower than the year prior.




### DC - New Purchase Contract to New Listing Ratio

• For the week, there were 231 new pending home sales for every 100 new listings.














































