# **PROMOTION OVERVIEW**

# **HOW TO ENTER**

- Download the NH Lottery mobile app (available in the Apple / Google Play Stores).
- Log in or create a NH Lottery account.
- Scan non-winning \$2 I Heart Bacon (Game #1675) scratch tickets enter.
- Tickets are not eligible for entry by mail.

# **Prize Details**

 A total of 10 winners will be randomly selected in each drawing to receive a years' supply of North Country Smokehouse Bacon. The years' supply includes a total of forty-eight (48) packs of bacon which will be delivered in a one-time shipment to winners.

#### **PLAYER ELIGIBILITY**

# Participants must:

- Be at least 18 years old.
- Be a U.S. resident.
- Have a valid NH Lottery account.
- Not be an employee or immediate household member of the New Hampshire Lottery Commission or its vendors (See Eligibility & Disqualification for details).

#### **TICKET INFO & LIMITATIONS**

#### **Ticket Entries**

- Each valid ticket = 1 entry.
- Limit 25 tickets per player per day. (12:00:00AM 11:59:59PM). Tickets do not need to be retained by players as proof of entry.

# **Ticket Eligibility**

- Only non-winning \$2 I Heart Bacon scratch tickets (Game #1675) tickets are eligible.
- Expired, stolen, or invalid tickets are not eligible for entry. Entries of game ticket serial numbers determined to be in an expired, stolen, or not part of a valid sold or promotional inventory status are not eligible and will be disqualified.

# **Subsequent Winner Eligibility**

- Winners are eligible to receive one (1) prize in each drawing.
- If a winner is selected in Drawing 1, they are eligible to also be selected as a winner in Drawing 2.

#### **WINNER NOTIFICATION & PRIZE CLAIMING**

# **Winner Notification**

- Winners will be randomly selected (via random number generator) from among all eligible entries received for each Drawing. Subject to verification of eligibility and compliance with these Official Rules, the potential winner will be declared the official winner.
- Winners will be contacted via email, phone, and/or by physical mail at the address registered to their NH Lottery accounts.

# **Drawing Dates**

Drawings dates are announced at least 30 days in advance and will be posted in the mobile app, announced in the NH Lottery Newsletter, Facebook, and posted at www.nhlottery.com/game/iheartbacon. The Drawing dates are determined by Lottery personnel, at the direction of the Executive Director.

# **Winner Announcement**

 Winners will be posted to the NH Lottery website and mobile app once the winners are successfully verified and notified (usually within 1 week of the Drawing but may be subject to delay).

# Claim Acceptance, Transfer, & Taxes

- Winners must complete a New Hampshire Lottery Claim Form within 30 days of notification.
- Prizes valued at \$600 and greater are subject to IRS Form W-2G tax reporting. Federal taxes estimated at 24% of the value of the prize package will be borne by the New Hampshire Lottery. The Lottery Commission will send winners IRS Form W-2G in the January following the Drawing. Any other taxes or fees not expressly noted, will be the responsibility of the Prizewinner.
- Completing and submitting a claim form constitutes the Winner's acceptance of the prize as awarded, even if fulfillment occurs at a later date. The Winner acknowledges that the prize may be subject to applicable tax reporting and that the Winner is responsible for paying taxes if applicable. Prizes may be gifted, sold, or otherwise transferred at the discretion of the Winner; however, the New Hampshire Lottery will not amend or reassign tax reporting for any transfer. Claims are final once the New Hampshire Lottery receives and processes the completed claim form.

# **Child Support Intercept**

Pursuant to RSA 284:21-v, the Lottery is required to review all lottery prize claims subject to federal tax reporting with a child support database provided by the Department of Health and Human Services (DHHS). In the event that a winner of any prize package described above owes child support, the winner shall have up to 21 days from the draw date to settle the total arrearage due as determined by DHHS to the DHHS, after which settlement the winner will be awarded the prize. Failure to settle any arrearage shall result in that winner's prize package being forfeit and the package will be issued to the first available alternate winner. The original winner(s) owing Child Support shall receive no other prize or compensation from the Lottery relating to this game.

#### **Prize Transfers**

 Prizes are non-transferable. In the event an official winner cannot claim their prize, the first available alternate winner will be notified.

# **FAQs**

# What is a Years' Supply of Bacon?

Winners will receive a single shipment that contains forty-eight (48) packs of a variety of North Country Smokehouse bacon.

# **Who is North Country Smokehouse**

North Country Smokehouse is a New Hampshire-based smokehouse known for crafting premium, small-batch smoked meats. They take pride in using time-honored, artisanal methods with carefully sourced ingredients to produce award-winning products. Rooted in New England tradition, they focus on authentic flavor and sustainable farming partnerships.

# Can I redeem my prize as a cash prize instead of bacon?

No. This prize cannot be substituted for cash or any other prize.

# What happens if I scan the same non-winning ticket twice?

Each valid ticket may be entered once. If you attempt to scan the same non-winning ticket again, you will see a notification stating the ticket has already been entered and will not earn additional entries. Only unique ticket entries are valid.

# Does the number of tickets I enter improve my odds of winning?

Yes, and you can enter up to 25 eligible tickets per day into the Drawing (12:00:00 AM – 11:59:59 PM).

# How will I know if I've won?

Winners are contacted using the information in their NH Lottery account—by email, phone, and/or physical mail. Make sure your contact details are up to date, so you don't miss a prize notification.

# What if I miss the notification or don't respond in time?

Winners must complete a claim form within 30 days. If you don't complete your claim in time, the prize will be awarded to an alternate winner, and you'll forfeit the prize. If this happens you will be informed by mail and will not be responsible for any taxes on the prize. However, we make every effort to contact winners, through every channel we can.

# I don't have a smartphone, can I enter on the website or mail in my tickets?

Second Chance Drawings are an exclusive feature of the NH Lottery mobile app. Tickets cannot be entered through the website or by mail.

# Am I eligible to win more than one Drawing?

Yes. If you are a winner in Drawing 1, you are eligible to be selected again in Drawing 2. That would be a lot of bacon!
