Official Rules

PROMOTION OVERVIEW

Enter non-winning \$10 JURASSIC PARK (Game #1673) scratch tickets from the New Hampshire Lottery into the Second Chance Promotion for a chance to win a Grand Prize Trip to Hawaii to participate in the \$1,000,000 JACKPOT CHALLENGE for chance to win up to \$1,000,000.

HOW TO ENTER

- Download the NH Lottery mobile app (*available in the Apple / Google Play Stores*).
- Log in or create a NH Lottery account.
- Scan non-winning \$10 JURASSIC PARK (Game #1673) scratch tickets to enter.
- Tickets are not eligible for entry by mail.

Drawing Details

- For each drawing, **one (1) Grand Prize Winner** and **one (1) Tri-State Semi-Finalist** will be randomly selected from each state (New Hampshire and Maine).
- Once each state has selected three **(3) Grand Prize Winners and three (3) Tri-State Semi-Finalists**, a final drawing will be announced. **One (1) of the six (6) Tri-State Semi-Finalists** will be randomly selected to be the **Tri-State Finalist** and will win a Grand Prize Trip to Hawaii to participate in the \$1,000,000 JACKPOT CHALLENGE.
- The remaining **five (5) Tri-State Semi-Finalists** will also receive prizes. Prizes and rules for the Tri-State drawing will be determined no later than ten (10) business days before the Tri-State drawing.

Prize Details

- **The Grand Prize Winners and Tri-State Finalist** will each win a six-day (6), five-night (5) trip (the “Grand Prize”) from Sunday, November 15, 2026 – Friday, November 20, 2026 for the winner and one (1) guest to Hawaii.
- . Each winner of a Grand Prize shall be referred to herein as a “Prizewinner”. Each Grand Prize includes:
 - Roundtrip coach airfare for two (2) people from any U.S. international airport in the 48 U.S. contiguous states, Hawaii, Alaska and Puerto Rico to Daniel K. Inouye International Airport in Honolulu, Hawaii (inclusive of all associated security fees, taxes and surcharges);
 - Ground transfers between the destination Airport and the destination hotel, and if necessary, between hosted activities and Event;
 - One (1) double occupancy room accommodations (room and room tax only) at a 3-star or better hotel in Oahu, Hawaii for five (5) nights;
 - One thousand dollars (\$1,000) spending money for the Prizewinner to be provided two (2) weeks prior to the scheduled trip departure date;
 - Admission for Prizewinner and guest to the Welcome Reception;
 - Prizewinner shall select one (1) tour or excursion from a variety of curated tours and activities in and around Oahu for Prizewinner and guest;
 - The Prizewinner, or duly authorized proxy, shall have one (1) chance to participate in the \$1,000,000 JACKPOT CHALLENGE (the “CHALLENGE” or “Event”) for a chance to win up to one million dollars (\$1,000,000) as described below.

\$1,000,000 JACKPOT CHALLENGE Details:

- The Event will be conducted according to event and security procedures generated by Scientific Games, LLC (“SG” or “Contractor”) and its third-party underwriters. Final official CHALLENGE details (“the “Challenge Details”) explaining how the CHALLENGE will be conducted will be provided to the Lottery no later than 120 days prior to the Event.

- Each Prizewinner (or assigned proxy) shall participate as a contestant (the “Contestant”) in the CHALLENGE together with Prizewinners from other participating lottery jurisdictions.
- Prizewinners’ guests may sit with Prizewinners in the audience but will not be eligible to be a Contestant in the CHALLENGE unless they have been designated as the Prizewinner’s proxy.
- Each Contestant will have one (1) chance to play a series of mini games for the chance to win cash prizes (collectively, the “Challenge Prize”). The total potential Challenge Prize that may be won by each Contestant, shall be based upon the round (defined below) in which the Contestant is participating, and will range from one thousand dollars (\$1,000) up to a chance to win one million dollars (\$1,000,000) (“Grand Prize”). The total Challenge Prize won, less tax withholdings, in the CHALLENGE by the Prizewinner will be mailed to the Prizewinner within thirty (30) business days after the official conclusion of the EVENT, but no later than December 31, 2026.
- The CHALLENGE will consist of four (4) rounds (each a “Round” or plural “Rounds”). Each Round will be played separately.
 - Round 1: Cash Prizes range from seventy-five dollars (\$75) up to one thousand dollars (\$1,000).
 - Round 2: Cash Prizes range from one hundred dollars (\$100) up to five thousand dollars (\$5,000).
 - Round 3: Cash Prizes range from five hundred dollars (\$500) up to fifty thousand dollars (\$50,000).
 - Round 4: Cash Prizes range from three hundred twenty-five dollars (\$325) up to one million dollars (\$1,000,000).

SG reserves the right to modify specific game play provided such change does not result in a lower expected payout for the Contestant for the modified portion. Prizewinners will be mailed the Challenge Details concerning the CHALLENGE prior to their trip departure.

Additional Conditions:

- Prizewinner and guest shall be required to comply with the Department of Homeland Security’s REAL ID Act and all other programs to attend and participate in the CHALLENGE. For more information, please see: <https://www.dhs.gov/real-id>.
- Prizewinners are subject to background investigation.
- If applicable, Prizewinner and guest shall be required to follow all health and safety protocols, including always wearing a facemask and following social distancing guidelines, as instructed by the event’s staff and volunteers and all federal, state, and local guidelines relating to COVID-19 or any pandemic.
- Prizewinner’s guest may sit with the Prizewinner but will not be eligible to be a participant in the CHALLENGE unless they have been designated as a Prizewinner’s proxy.
- Prizewinner will be mailed the Challenge Details concerning the CHALLENGE prior to their trip departure.

- Age and other eligibility requirements to win the Trip Prize shall be determined by the LOTTERY; however, the minimum age requirement to play the CHALLENGE is eighteen (18) years per Hawaii State Law. The Prizewinner or their proxy must be eighteen (18) years of age to be eligible to participate in the CHALLENGE.
- All CHALLENGE Rounds will be audited by an independent auditor.
- All Cash Prizes in the CHALLENGE are underwritten by either SG, third parties, or both. Cash Prizes of one million dollars (\$1,000,000) are awarded as a lump sum payment to the Prizewinner, less tax withholdings.
- SG will issue an IRS Tax Form W-2G for the prize amounts won during the CHALLENGE.
- The Trip Prize is not for resale and may be transferred once, prior to the trip being booked. However, the CHALLENGE cash prize win will be awarded to the Prizewinner and all tax liability and responsibility remains with the original Prizewinner, regardless of transfer.
- The payment of the CHALLENGE Cash Prizes awarded to each Prizewinner during the CHALLENGE are the sole responsibility of SG, third parties, or both, subject to the terms below. Cash Prize awards are not considered won by a Contestant, and are not payable unless and until the third party underwriter (the “**Risk Counterparty Representatives**”) of such Cash Prize payouts and SG’s Event official certify that the CHALLENGE has been conducted appropriately and in accordance with the official Event and Security Procedures, that a Contestant has validly won the Cash Prize award pursuant to the Challenge Details and the Prizewinner is entitled to receive the Cash Prize award, and the Risk Counterparty Representatives will then be required to pay the Cash Prize awards to the Prizewinners. Participating Lotteries shall have no liability for any Cash Prize amounts awarded collectively in the CHALLENGE and the third-party underwriter of such Prize (where applicable) has accepted the obligation to pay the Cash Prize to the Prizewinners. Participating lotteries shall have no liability for any CHALLENGE Cash Prizes.
- All Cash Prizes won by the Contestants will be subject to the NH Lottery’s debt setoff procedures. The Prizewinner may not choose to receive the cash equivalent of the trip portion of the Trip Prize.
- FAILURE TO COMPLY WITH ANY OF THE OFFICIAL PROMOTION AND/OR CHALLENGE DETAILS, PROMOTION AND/OR EVENT AND SECURITY PROCEDURES, ANY OTHER GUIDELINES, OR CODES OF CONDUCT SET FORTH BY SG, MAY RESULT IN A CONTESTANT’S DISQUALIFICATION AT SG’S SOLE AND ABSOLUTE DISCRETION AND/OR THE REVOCATION OF ANY CASH PRIZE WON DURING THE CHALLENGE.

The CHALLENGE is being administered by SG. Any questions regarding the CHALLENGE, including questions regarding the assignment of proxies, Cash Prize payments, and tax liability or withholding for CHALLENGE Cash Prizes, should be directed to SG at 1-800-201-0108. PLAYER ELIGIBILITY

Participants must:

- Be at least 18 years old.
- Be a U.S. resident.
- Have a valid NH Lottery account.
- Not be an employee or immediate household member of the New Hampshire Lottery Commission or its vendors (See **Eligibility & Disqualification** for details).

TICKET INFO & LIMITATIONS

Ticket Entries

- Each valid ticket = 1 drawing entry.
- Limit 25 tickets per player per day. (12:00:00AM – 11:59:59PM). Tickets do not need to be retained by players as proof of entry.

Ticket Eligibility

- \$10 JURASSIC PARK (Game #1673) scratch tickets purchased in NH are eligible.
- Expired, stolen, or invalid tickets are not eligible for entry. Entries of game ticket serial numbers determined to be in an expired, stolen, or not part of a valid sold or promotional inventory status are not eligible and will be disqualified.

Subsequent Winner Eligibility

- Grand Prize Winners are only eligible to win one Grand Prize Trip in New Hampshire and Maine in any JURASSIC PARK Second Chance Drawings (in either New Hampshire or Maine).
- In the event a Tri-State Semi-Finalist were to be drawn as a Grand Prize Winner in a subsequent drawing (in either New Hampshire or Maine), they may forfeit their place as a Tri-State Semi-Finalist to gain eligibility to become a Grand Prize Winner.

My603Rewards Eligibility

- For the duration of the Second Chance Promotion, eligible non-winning tickets scanned are entered into the Second Chance Drawing and do not receive My603Rewards points. Eligible winning tickets will receive My603Rewards points when scanned.
- Once the Second Chance Drawing Promotion ends, both eligible winning and non-winning tickets will become eligible to receive My603Rewards points.

WINNER NOTIFICATION & PRIZE CLAIMING

Winner Notification

- Winners will be randomly selected (via random number generator) from amongst all eligible entries received for each Drawing. Subject to verification of eligibility and compliance with these Official Rules, the potential winner will be declared the Official Winner.
- Winners will be contacted via email, phone, and/or by physical mail at the address registered to their NH Lottery accounts.

Drawing Dates

- Drawings dates are announced at least 30 days in advance and will be posted in the mobile app, announced in NH Lottery communications, and posted at www.nhlottery.com/game/jurassicpark. The Drawing dates are determined by Lottery personnel, at the direction of the Executive Director.

Winner Announcement

- Winners will be posted to the NH Lottery website and mobile app once the winners are successfully verified and notified (usually within 1 week of the Drawing but may be subject to delay).

Claim Information & Taxes

- Winners must complete and return a New Hampshire Lottery Claim Form within 30 days of notification.
- Prizes \$2,000 and greater are subject to IRS Form W-2G tax reporting and 24% federal withholding. The Lottery Commission will withhold federal tax from the prize value at the applicable rate set by the United States Internal Revenue Service, currently 24%.
- Any taxes not expressly withheld remain the responsibility of the winner.
- By submitting a completed claim form, a winner accepts the prize as awarded, even if fulfillment occurs at a later date, and acknowledges that the prize may be subject to applicable tax reporting. Once submitted, a claim is final and cannot be changed, canceled, or exchanged, regardless of the winner's ability to attend and/or use the prize. Unused prizes do not qualify for claim reversal, refund, or substitution.
- Prize fulfillment and issuance of tax forms for the Grand Prize Trip and Challenge Prizes will be managed and administered by the Contractor.

Child Support Intercept

- Pursuant to RSA 284:21-v, the Lottery is required to review all lottery prize claims subject to federal tax reporting with a child support database provided by the Department of Health and Human Services (DHHS). In the event that a winner of any prize package described above owes child support, the winner shall have up to 21 days from the draw date to settle the total arrearages due as determined by DHHS to the DHHS, after which settlement the

winner will be awarded the prize. Failure to settle any arrearages shall result in that winner's prize package being forfeited and the package will be issued to the first available alternate winner. The original winner(s) owing Child Support shall receive no other prize or compensation from the Lottery relating to this game.

Prize Transfers

- Tri-State Semi-Finalists serve as the first alternates in their respective drawings should a Grand Prize Winner choose to decline or be deemed ineligible to claim their prize. If a Tri-State Semi-Finalist is elevated to Grand Prize Winner, the next alternate from that drawing will be notified to become a Tri-State Semi-Finalist.

Proxy Representation

- In the event that a verified Prizewinner is unable to attend the CHALLENGE in person or is physically unable to participate in the prize activity, the Prizewinner may designate a Proxy to participate on their behalf. The designated Proxy must be at least eighteen (18) years of age and must be approved by the New Hampshire Lottery Commission in advance of the Event. The Proxy may not be an employee or immediate household member of a New Hampshire Lottery or Maine Lottery employee or vendor. If a verified Prizewinner is unexpectedly unable to attend and does not designate a Proxy in advance, the New Hampshire Lottery Commission or its designee reserves the right to assign a Proxy to participate in the CHALLENGE on the Prizewinner's behalf. All outcomes of the Event—whether determined by the Prizewinner or their designated Proxy—are final.

Privacy & Publicity

- All information submitted online by entrants is subject to, and will be treated in a manner consistent with, the New Hampshire Lottery Commission's (hereinafter, "the Lottery") **Privacy Policy**. The Lottery, at its discretion, reserves the right to select and/or change the prize(s) to be awarded as part of this Promotion. Entrants must be a US Person, 18 years of age or older. Void where prohibited or restricted by law.
- Acceptance of the prize constitutes permission for the Lottery and their agencies to use the prize winner's name and/or likeness worldwide, in perpetuity, for purposes of advertising and trade without further compensation, notification or permission unless prohibited by law, in all media now known or hereafter devised. - The Lottery, at its sole discretion, may disqualify an entry, winner, or designee from participating in any aspect of the drawings if they deem or suspect that such person has engaged in or has attempted to engage in any of the following:
 - Act in violation of these Official Rules, **Terms and Conditions**, or **Privacy Policy**;
 - Act with intent to annoy, harass or abuse any other person;

FAQs

What will happen at the \$1,000,000 JACKPOT CHALLENGE Event?

Prizewinners will travel to Hawaii to take part in a once-in-a-lifetime Event where each Prizewinner will have the chance to win cash prizes through a series of exciting games up to \$1,000,000.

What happens if I scan the same non-winning ticket twice?

Each valid ticket may be entered once. If you attempt to scan the same non-winning ticket again, you will see a notification stating the ticket has already been entered and will not earn additional entries. Only unique non-winning ticket entries are valid.

Does the number of tickets I enter improve my odds of winning?

Yes, and you can enter up to 25 eligible tickets per day into the Drawing (12:00:00 AM – 11:59:59 PM).

How will I know if I've won?

Winners are contacted using the information in their NH Lottery account—by email, phone, and/or physical mail. Make sure your contact details are up to date, so you don't miss a prize notification.

What if I miss the notification or don't respond in time?

Winners must complete a claim form within 30 days. If you don't complete your claim in time, the prize will be awarded to an alternate winner, and you'll forfeit the prize. If this happens you will be informed by mail and will not be responsible for any taxes on the prize. However, we make every effort to contact winners, through every channel we can.

I don't have a smartphone; can I enter on the website or mail in my tickets?

Second Chance Drawings are an exclusive feature of the NH Lottery mobile app. Tickets cannot be entered through the website or by mail.

Am I eligible to win more than one Prize?

If you are named a Grand Prize Winner (in either New Hampshire or Maine) you are not eligible to be drawn as the winner for any additional prizes. However, if you are named as a Tri-State Semi-Finalist and were to later be drawn as a Grand Prize Winner (in either New Hampshire or Maine), you may opt to forfeit your prize as a Tri-State Semi-Finalist to become a Grand Prize Winner.

Can I enter my JURASSIC PARK tickets I purchased in Maine, or can I enter my New Hampshire \$10 JURASSIC PARK scratch tickets into the Maine drawing?

The \$10 JURASSIC PARK scratch tickets from New Hampshire can only be entered into the NH Lottery drawings and likewise, JURASSIC PARK tickets purchased in Maine can only be entered into Maine's Second Chance Drawings.

If I am a Grand Prize Winner and unable to attend or am not physically able to participate in the Event, can someone else participate for me?

If you are unable to attend the Event yourself, you can designate someone ahead of time to participate on your behalf or the NH Lottery or its designee can assign a Proxy for you at time-of the event. See **Proxy Representation** section for more information.
