

AAD 8: Chronic Skin Conditions: Patient Reported Quality-of-Life

Electronic health records (EHRs) collect and organize notes, medication lists, and patient information using various formats. With providers also documenting this information in unique ways, this can potentially cause confusion and an increased timeline for measure mapping with DataDerm. This tip sheet can help you manage reporting requirements for performance measures and streamline standard documentation practices to allow seamless data pull into DataDerm.

The DataDerm team will work with you to connect DataDerm with your EHR to extract data. To make the process as smooth as possible, it helps to document key elements of patient care. DataDerm cannot read scanned images of any kind, including scanned images for labs, letters to physicians, pathology reports, follow-up plans, and dates. If you have scanned images with information needed for your measures, please add a note in your chart with the date and required patient information for this data to be accurately collected.

This tip sheet can assist paper-based practices in standardizing documentation practices. Keeping notes in the patient's paper chart of all documentation requirements will assist you when reporting for this measure.

For all patients, aged 18 years and older, seen for a current diagnosis of one of the applicable skin conditions, document the following in your medical records:

- ☐ Diagnosis of Psoriasis (ICD-10-CM): L40.0, L40.1, L40.2, L40.3, L40.4, L40.8, L40.9
- ☐ Diagnosis of Atopic Dermatitis (ICD-10-CM): L20.82, L20.84, L20.89, L20.9
- ☐ Diagnosis for Contact Dermatitis (ICD-10-CM):
 - Irritant Contact Dermatitis: L24.0, L24.1, L24.2, L24.3, L24.4, L24.5, L24.6, L24.7, L24.81, L24.89, L24.9
 - Allergic Contact Dermatitis: L23.0, L23.1, L23.2, L23.3, L23.4, L23.5, L23.6, L23.7, L23.81, L23.89, L23.9, L25.0, L25.1, L25.2, L25.3, L25.4, L25.5, L25.8, L25.9, L56.0, L56.1, L56.2
- ☐ Diagnosis for Nummular Dermatitis (ICD-10-CM): L30.0
- ☐ Diagnosis for Other/Unspecified Dermatitis (ICD-10-CM): L30.1, L30.2, L30.3, L30.8, L30.9
- ☐ Diagnosis of Acne (ICD-10-CM): L70.0, L70.1, L70.2, L70.3, L70.5, L70.8, L70.9

AAD 8: Chronic Skin Conditions: Patient Reported Quality-of-Life

- ☐ Diagnosis of Keloids (ICD-10-CM): L91.0, L73.0
- ☐ Patient encounter during reporting period (CPT and/or CPT with telehealth modifiers): 99201, 99202, 99203, 99204, 99205, 99211, 99212, 99213, 99214, 99215, 99241, 99242, 99243, 99244, 99245, GQ, GT, 95, POS 02
- ☐ Document the completed patient-reported quality of life assessment with care plan in the medical record
- ☐ If the quality of life assessment is not completed, note in the medical record, if applicable:
 - Patient declined to complete tool
 - Patient has identified a skin condition that is not denominator eligible as the main condition on their assessment

Additional Tips:

- ☐ Collect **once per reporting period** for patients with a current diagnosis of the applicable skin conditions during the performance period.
- ☐ Report the patient's response to quality of life regarding the **main skin condition** the patient is visiting the physician for if the patient has multiple skin conditions.
Use the template within the measure specification to ensure all necessary data elements are captured.
