I recommend against use of racial descriptors as nouns (i.e. "Blacks") but instead in adjectival form (i.e. Black people) as recommended by the AMA Manual of Style Committee. See: https://jamanetwork.com/journals/jama/fullarticle/2776936 Given the lack of strong data in support, is there any reason to discuss potential harms (exposure to ingredients that have recently invited scrutiny, Vit D insufficiency, etc)? Obviously, the data for harms is a mess, but so apparently are data in support of photoprotection for skin cancer prevention -- and the lack of a skin cancer protective effect is biologically plausible. You do a nice job summarizing the value in patients with photosensitive disorders and recognizing the diversity of skin types among patients from Black, Latino and Asian populations.







I think this item is out of place in the order of this survey, so it might be confusing.



Is there any evidence that plopping residents for a short stint on the RBRVS/CPT Committee would attract them to the causes? I do not see a benefit for the residents nor for the committee from this initiative. It takes some time for anyone in established practice to attend, understand and evolve within RUC/CPT meeting process. A resident on this committee would not be exposed to the actual CPT or RUC proceedings and would be unable to glean practical information about the CPT and the RUC. This committee is designed to promote communication and cohesive action between the RUC and CPT groups, and as such, resident presence would be of dubious benefit. I do not approve of this initiative.



Page 101, Item 2 (line 101): we may want to discuss the details of procedure documentation, both those spelled out in the document, and details not included. Specifically, what does "size " refer to? Preoperative lesion, postoperative, intraoperative? Should the need to document what actually was done be prescribed? "...including the unique aspects of each procedure...along with any anatomic or morphologic specifics..." is listed. What does this actually mean? What would unique anatomic/morphologic specific be? I think that it may be more beneficial to be less specific and more general, such as: "describe the procedure, including its location and details of the procedure, including specifics that would justify the reported CPT codes". Item 3, page 102: recommend care in how we present the use of macros and SOPs, as identical language describing procedures done on different patients may end up suffering from lack of individualization, leading, upon audit, to claims denials by payers. Maybe a disclaimer suggesting that one should take care in individualizing procedure descriptions would help.



With respect to "Review of Coding and Documentation Guidance...", it states that the articles in question were well vetted prior to publication. So, how many layers of vetting are sufficient? Will having another "oversight" group vetting what has already been beaten down and refined by multiple individuals demoralize those who participate in the formative process, and also, lead to delays in publication? I do not recall seeing the edits produced by this group. May have missed them, but as one involved with most of the projects mentioned, would appreciate seeing what is being done. I am concerned about having "too many cooks" in the process. However, I also feel that we as a society should be distributing the most precise information possible. So, I voted for approval of the document, since it is for information only, but I am concerned about the functions of the Ad Hoc group, particularly since this is the first that I see of it. Sort of creates a "big brother" situation.
