

# 2023 MIPS Reporting Options

Use the chart below to determine what you should report in each MIPS category to avoid the penalty or earn an incentive. MIPS includes all eligible encounters from all payers, not just Medicare patient encounters. However, if you are a small practice reporting via claims or the CMS Web Interface, only Medicare Part B patients are included.

**Instructions on using the chart:** Report the requirements in each category to achieve the points needed for the desired outcome. These are only suggested options for reporting; there may be other options for achieving the score needed to avoid the penalty or earn an incentive.

	EHR  (Automatic PI exemption applied)	(Quality category weight 40%) Report 6 measures that can achieve a maximum of 10 points for all eligible encounters for the full year between Jan. 1 – Dec. 31, 2023. PLUS 6 bonus points for small practices added to the numerator.  <b>(44 points)</b>	(IA category weight 30%) Attest to 1 high-weighted improvement activity such as reporting through DataDerm (for a minimum of 90 consecutive days between Jan. 1 – Dec. 31, 2023).  <b>(30 points)</b>	Not applicable. CMS automatically applies exemption and reweights PI category weight to Quality category.	CMS will automatically assess and add to final MIPS score. If you are exempt from the cost category (in addition to the already applied PI exemption) this category's weight will be redistributed to quality and IA making each of them 50%.	<b>74 + up to 30 more for Cost</b>  (if max points added)

	EHR	Report 6 quality measures that can achieve a maximum of 10 points each for <b>all</b> eligible encounters between Jan. 1 – Dec. 31, 2023.  <b>(30 points)</b>	Attest to 2 high-weighted improvement activities for a minimum of 90 consecutive days between Jan. 1 – Dec. 31, 2023.  <b>(15 points)</b>	Report 5 or 6 PI measures from each of the 4 objectives for <b>all</b> eligible encounters between Jan 1 – Dec 31, 2023: <ul style="list-style-type: none"><li><u>e-Prescribing</u>: PI_EP_1* &amp; PI_EP_2*</li><li><u>Health Information Exchange</u>: PI_HIE_1* &amp; PI_HIE_4* or PI_HIE_5 or PI_HIE_6</li><li><u>Provider to Patient Exchange</u>: PI_PEA_1</li><li><u>Public Health and Clinical Data Exchange</u>: PI_PHCDRR_1* &amp; PI_PHCDRR_3*</li></ul> Additional bonus measure available for Public Health and Clinical Data Exchange.  <b>(25 points)</b>	CMS will automatically assess and add up to 30 points maximum to final MIPS score. If exempt from Cost category, 30% weight applied to PI category.	<b>70 + up to 30 more for Cost</b>  (if max points added)
