

Official Rules & Regulations: Legislative Conference Giveaway

How to enter the Legislative Conference Giveaway (the “Contest”):

Comment or retweet the name of the U.S. state in which you currently practice dermatology on the @AADmember social media posts about the Legislative Conference Giveaway. Participants must be first-time attendees of the conference. Open to U.S. members only of the American Academy of Dermatology Association (AADA).

Prize: Five (5) randomly selected winners will each be granted one (1) free trip including (1) roundtrip coach airfare ticket and 2 nights single occupancy at the Conrad hotel to the 2022 AADA Legislative Conference in Washington, D.C. from September 18 to 20, 2022. Free airfare and hotel are only valid for this event and are non-transferable to any other individual or AADA meeting. The odds of winning a prize depend upon the number of individuals who participate in the contest. Prize winners are responsible for any applicable federal, state, and local taxes on their prize. To comply with federal tax reporting requirements, AADA will issue IRS Form 1099 to any prize winners whose total prize has a value of \$600 or more, which will require winners to submit to AADA IRS Form W-9 containing certain personal information.

Prize Eligibility: No purchase necessary to participate or win. Only open to U.S. members of the American Academy of Dermatology Association who are classified in one of the following categories: Physician, Adjunct, Life, Honorary, Medical Fellow in U.S. AAD-approved programs. Participants must be first-time attendees of the Legislative Conference. Only one winner from each state will be chosen. Each winner must purchase air fare 30 days in advance of the conference.

Winner Selection: Five (5) winners will be randomly selected from the total entries submitted on Twitter, Facebook, and Instagram between [date-date]. All five (5) winners must be from different U.S. states. If two or more winners are from the same state, another participant will be randomly selected. All five (5) winners must be verified as first-time attendees of the conference. If a winner has attended a previous Legislative Conference, another participant will be randomly selected. The five (5) winners will be contacted through a private message on Instagram (Instagram Direct) or Twitter Direct Message. If a potential winning entrant does not respond to correspondence within 72 hours, the potential winning entrant will be disqualified, and a new winning entrant will be selected by random drawing.
