How to Enter:	To enter the Promotion, the entrant must complete the following steps during the Promotional Period: a) spend at least \$50 on any Bundaberg Rum product/s in one (1) transaction, to share, from any Liquor Legends store within Australia or at https://liquorlegends.com.au/ ("Participating Venues"); and b) scan their Liquor Legends rewards card at checkout (for in-store purchases) or be logged into their account at checkout (for online purchases). If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, or suspend or modify a prize, subject to State or Territory regulation.
21. The Promoter reserves the right, at any time, to validate and check the authenticity of entries and entrant's details (including an entrant's identity, age and place of residence). In the event that a winner cannot provide suitable proof as required by the Promoter to validate their entry, the winner will forfeit the prize in whole and no substitute will be offered. Incomplete, indecipherable, inaudible, incorrect and illegible entries, as applicable, will at the Promoter's discretion be deemed invalid and not eligible to win.
