- Fall Regional Meetings
  - Considering hosting these virtually for a number of reasons:
    - Recruitment in spring means that we will be expanding the number of participating practices, potentially necessitating adding an 8th or 9th region
    - Practices find the meetings challenging to attend and have requested a virtual option
    - As participation in population health CQIs increases, practices have additional meeting requirements across programs
    - Would allow for a larger range of keynote speakers
    - Additional attendees from the practice would be able to attend

Note: only applies to fall, spring regional meeting will continue to be in person every year.

## **Operationalizing Fall Regional Meetings**

- Would hold ~ 4 sessions, in the evening. Will poll the collaborative on a convenient time (e.g. 5:30pm-7:30pm, 6pm-8pm)
- Would want to keep the regions together, as we want to continue to foster the relationships that have been built over our previous meetings.
- This will be a trial approach- we are concerned about engagement in a virtual environment. For breakout sessions, the expectation will be camera on and full participation.
- We will also be considering how to potentially increase PO meetings in the future (either using monthly calls differently or in 2025 adding another CWM).

- Considerations and Conditions
  - This would be a trial approach. We are concerned about engagement on virtual calls.
  - Expectation for in person attendance at spring regional meetings remains. We do not plan to ever go fully virtual for our regional meetings, but hopefully this alleviates some burden.
  - WE ARE AWAITING BCBSM APPROVAL ON THIS APPROACH. UNTIL
     WE RECEIVE AGREEMENT FROM BCBSM, THIS IS NOT SET IN STONE.

## **Practice Level Users- Admin Portal**


We are going to offer access to the administrative portal for clinical champions and practice liaisons. This would be a limited view that lets them see practice level information only.

This should reduce questions on if a VBR metric has been met both to you as the PO leads and to us as the coordinating center.

## **Process for Practice Level Users**

- **New "User Tab"** POs can view the practice level users, and can click Review and you will also have the option to revoke access if someone leaves a practice.
- If someone goes to the Admin Portal and is not logged in, there will be an option to apply for an account.
  - If a person already has an assigned role in a practice (e.g. clinical champion or practice liaison, they will be immediately approved for access.
  - If they do not have a role in the practice, the application will be sent to you
    as the PO to review and approve before granting access.

Logged-in users with practice-level access can:


- View VBR forms submitted by their practice. This includes forms for practice-level and provider-level VBR.
