Practice Recruitment Considerations

If we receive over 75 practices nominated to join MCT2D, we will be looking at the following criteria to determine who to enroll:

- Geographic location- state location and underserved areas (information from PGIP list)
- Safety Net Practice/FQHC (information from PGIP list)
- Independent practices (information from PGIP list)
- PDCM practices (information from PGIP list)
- Practices that have an embedded pharmacist (information provided by PO in the portal)
- Percentage of Medicaid patients (information provided by PO in the portal)
- Other considerations (information provided by PO in the portal)
