

Tom de Swaan

Tom de Swaan was appointed to the Supervisory Board of ABN AMRO Bank N.V. as Chair and member effective 12 July 2018 and reappointed effective 20 April 2022 for a period of four years. His term of appointment will expire upon the closing of the annual general meeting in 2026.

Tom started his career at De Nederlandsche Bank N.V. (DNB) in 1972. In 1983, Tom became a Deputy Member and after a period of two years full Member of the Board in charge of DNB's accounting, legal and banknote departments. In 1992 he moved over to the regulatory and policy side of DNB as the Board Member responsible for Banking Supervision. In this capacity he became a member and subsequently Chair of the European Monetary Committee's Banking Supervisory Committee, and member and subsequently Chair of the Basel Committee for Banking Supervision.

In 1999, Tom joined the Managing Board of ABN AMRO as Chief Financial Officer and Chief Risk Officer. In 2000 he also became a non-executive member of the Board of the Financial Services Authority in the UK. In 2006, Tom stepped down from his executive role at ABN AMRO and held various non-executive positions at GlaxoSmithKline, DSM and Ahold. In 2006, Tom joined the Board of Zurich Insurance Group and he was appointed as Chair of the Board in 2013. Tom held various other board and advisory functions in the banking sector, under which the position of Chair of the Supervisory Board of Van Lanschot Bankiers as of 2007, and in other sectors. On the not for profit side Tom was Chair of the Supervisory Council of the Antoni van Leeuwenhoekziekenhuis/Netherlands Cancer Institute until 1 June 2019 and member of the Board of the Foundation Premium Erasmianum until 24 May 2022. He was also Chair of the Supervisory Council of the Nederlandse Opera, Chair of the Board of Het Muziektheater, and Treasurer of the Board of the Koninklijk Concertgebouworkest.
