Supplement to the Registration Document dated 7 May 2020

This supplement (the "**Supplement**") is supplemental to, forms part of and must be read and construed in conjunction with, the registration document dated 7 May 2020 as supplemented by the supplement dated 15 May 2020 (the "**Registration Document**"). This Supplement, together with the Registration Document, constitutes a registration document for the purposes of the Regulation (EU) 2017/1129 (the "**Prospectus Regulation**"). The Registration Document forms part of any prospectus of ABN AMRO Bank N.V. consisting of separate documents within the meaning of the Prospectus Regulation, in respect of securities described in such other prospectuses or constituent parts thereof, and as of the date of this Supplement relates to the base prospectuses consisting of separate documents in relation to ABN AMRO Bank N.V.'s (i) \$25,000,000,000 Program for the Issuance of Senior Preferred/Senior Non-Preferred/Subordinated Medium Term Notes dated 7 May as supplemented by the supplement thereto dated 1 July 2020, (ii) Programme for the Issuance of Medium Term Notes 7 August 2020 , (iii) €40,000,000,000 Covered Bond Programme dated 21 August 2020 and (iv) €40,000,000,000 Covered Bond Programme 2 dated 21 August 2020. This Supplement supplements the Registration Document and any such prospectus consisting of separate documents.

Terms given a defined meaning in the Registration Document shall, unless the context otherwise requires, have the same meaning when used in this Supplement. To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference into the Registration Document by this Supplement and (b) any other statement in or incorporated by reference into the Registration Document, the statements in (a) above will prevail.

ABN AMRO Bank N.V. (in its capacity as Issuer) accepts responsibility for the information contained in this Supplement and declares that, to the best of its knowledge, the information contained in this Supplement is in accordance with the facts and this Supplement makes no omission likely to affect its import.

This Supplement has been approved by The Netherlands Authority for the Financial Markets (*Stichting Autoriteit Financiële Markten*, "**AFM**") as the competent authority in the Issuer's home Member State pursuant to the Prospectus Regulation. The AFM has only approved this Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the Prospectus Regulation. Such an approval should not be considered as an endorsement of the Issuer that is the subject of this Supplement.

No person is or has been authorised by the Issuer to give any information or to make any representation not contained in or not consistent with the Registration Document, and this Supplement, and, if given or made, such information or representation must not be relied upon as having been authorised by the Issuer.

The Registration Document and this Supplement should not be considered as a recommendation by the Issuer that any recipient of the Registration Document or this Supplement should purchase securities of the Issuer. AMENDMENTS OR ADDITIONS TO THE REGISTRATION DOCUMENT

On 12 August 2020 ABN AMRO Bank N.V. published its report titled "*Interim Report & Quarterly Report Second quarter 2020*" (the "**Interim Financial Report 2020**"). A copy of the Interim Financial Report 2020 has been filed with the Netherlands Authority for the Financial Markets (*Autoriteit Financiële Markten*). By virtue of this Supplement, the Interim Financial Report 2020 is incorporated in, and forms part of, the Registration Document.

With effect from the date of this Supplement the information appearing in, or incorporated by reference into, the Registration Document shall be supplemented in the manner described below (references to page numbers are to the pages of the registration document dated 7 May 2020):

In Section 3. *Documents Incorporated by Reference*, on page 29, the following new paragraph (o) shall be inserted (with the deletion of "and" at the end of paragraph (m) and the replacement of "," at the end of paragraph (n) with "; and"):

The information set out therein is unaudited,".

In Section 3. *Documents Incorporated by Reference*, on page 29, the following paragraph shall be inserted:

"In its review report included in the Interim Financial Report 2020, the independent auditor has included the following Emphasis of matter relating to uncertainty about Corona: "The developments around the Corona (Covid-19) pandemic have a profound impact on people, society and on the economy. This impacts operational and financial performance of organizations and the assessment of the ability to continue as a going concern. The impact may continue to evolve, giving rise to complexity and inherent uncertainty. ABN AMRO is confronted with this uncertainty as well. The condensed consolidated interim financial statements and our review report thereon reflect the conditions at the time of preparation, including the uncertainty and the impact on significant assumptions and estimations, that are disclosed in the Risk, funding & capital information section (chapters 'Risk developments' and 'Update on Covid-19 relief measures') of the Interim Financial Report 2020 and in the notes to the condensed consolidated interim financial statements in note 1 'Accounting policies – Critical accounting estimates and judgments' of the Interim Financial Report 2020. We draw attention to these disclosures. Our conclusion is not modified in respect of this matter"."
