Ms Roobeek was also chairperson of the national Centre for Science and Technology / NEMO Science Centre from June 2005 to June 2013, vice-chairperson of the board of Stichting VUmc fonds Amsterdam from January 2003 to September 2015, a member of the VROM Council and later the RLI Council from April 2009 to March 2012, a member and treasurer of NexusLabs Foundation from May 2012 to September 2013, member of Sirius Leading Expert for Excellence in Higher Education from October 2011 to January 2015 and chairperson, and in the last months board member, of Vereniging REFILL from February 2012 to September 2015. She was member of the Advisory Board of Vereniging Koninklijke Horeca Nederland from August 2010 to April 2016.
