




Carteira de Crédito (R\$ milhões)



Provisão (R\$ milhões)




Índice de Basiléia (%)




Receitas (R\$ milhões)



Despesas (R\$ milhões)




Índice de Eficiência (%)




Patrimônio Líquido (R\$ milhões)



Lucro Líquido (R\$ milhões)




ROAE (Return on Average Equity) (%)








Qualidade da Carteira de Crédito

Saldo de PDD (% da carteira de empréstimos)




Carteira de Crédito por rating BACEN (R\$ milhões)




Ativos e Passivos por vencimento

Ativos e Passivos por vencimento (R\$ milhões) – (Dezembro'18)




GAP acumulado (R\$ milhões)
