This document constitutes the Final Terms of the Senior Preferred MREL Notes described herein for the purposes of the Prospectus Regulation and must be read in conjunction with the base prospectus consisting of separate documents (i.e. (i) the Securities Note and (ii) the registration document of the Issuer dated 2 June 2026 as supplemented by a supplement dated 14 August 2026 (the "**Registration Document**" and together with the Securities Note, the "**Base Prospectus**", as supplemented by a supplement dated 14 August 2026) in order to obtain all the relevant information. Full information on the Issuer and the offer of the Senior Preferred MREL Notes is only available on the basis of the combination of these Final Terms and the Base Prospectus. 2. RATINGS

Ratings: The Senior Preferred MREL Notes to be issued are expected to be rated:

S & P: A

As defined by S&P, an "A" rating means that the Issuer has strong capacity to meet its financial commitments, but the Notes are somewhat more susceptible to adverse economic conditions.

Moody's: A1

As defined by Moody's, an "A" rating means that the Notes are considered upper-medium-grade and are subject to low credit risk. The modifier 1 indicates a ranking in the higher end of that generic assessment category.

Fitch: AA-

As defined by Fitch, an "AA" rating means that the Notes are judged to be of very high credit quality and denotes expectation of very low default risk. It indicates very strong capacity for payment of financial commitments. This capacity is not significantly vulnerable to foreseeable events. The modifier - indicates relative differences of probability of default or recovery for issues.

S&P Global Ratings Europe Limited ("**S&P**"), Moody's France SAS ("**Moody's**") and Fitch Ratings Ireland Limited ("**Fitch**") are established in the EEA and registered under Regulation (EC) No 1060/2009, as amended.

4. **REASONS FOR THE OFFER AND ESTIMATED NET AMOUNT OF PROCEEDS**

Reasons for the Offer

An amount equivalent to the proceeds of the Senior Preferred MREL Notes will be used to finance and refinance, in whole or in part, green bond eligible assets ("**Eligible Assets**") in accordance with the Issuer's green bond factsheet prepared by the Issuer in accordance with Annex I of Regulation (EU) 2023/2631 of the European Parliament and of the Council of 22 November 2023 (the "**EU Green Bond Regulation**").
