This supplement (the "**Supplement**") is supplemental to, forms part of and must be read and construed in conjunction with, the registration document dated 6 June 2025, as supplemented on 15 August 2025, 28 November 2025 and 16 February 2026 (the "**Registration Document**") and any prospectus of ABN AMRO Bank N.V. consisting of separate documents of which the Registration Document forms part. This Supplement, together with the Registration Document, constitutes a registration document for the purposes of the Regulation (EU) 2017/1129 (the "**Prospectus Regulation**"). The Registration Document forms part of any prospectus of ABN AMRO Bank N.V. consisting of separate documents within the meaning of the Prospectus Regulation, in respect of securities described in such other prospectuses or constituent parts thereof, and as of the date of this Supplement relates to the base prospectuses consisting of separate documents in relation to ABN AMRO Bank N.V.'s (i) \$25,000,000,000 Program for the Issuance of Senior Preferred/Senior Preferred MREL/Senior Non-Preferred/Subordinated Medium Term Notes dated 6 June 2025, (ii) Programme for the Issuance of Medium Term Notes dated 15 August 2025, (iii) Covered Bond Programme dated 15 August 2025 and (iv) (Retained) Covered Bond Programme 2 dated 15 August 2025 as supplemented on 15 January 2026. This Supplement supplements the Registration Document and any such prospectus consisting of separate documents.

Terms given a defined meaning in the Registration Document shall, unless the context otherwise requires, have the same meaning when used in this Supplement. To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference into the Registration Document by this Supplement and (b) any other statement in or incorporated by reference into the Registration Document, the statements in (a) above will prevail.

ABN AMRO Bank N.V. (in its capacity as Issuer) accepts responsibility for the information contained in this Supplement and declares that, to the best of its knowledge, the information contained in this Supplement is in accordance with the facts and this Supplement makes no omission likely to affect its import.

This Supplement has been approved by The Central Bank of Ireland (the "**Central Bank**") as the competent authority in the Issuer's home Member State pursuant to the Prospectus Regulation. The Central Bank has only approved this Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the Prospectus Regulation.
