Following her transfer to Europe, she was able to broaden her experience and obtained leadership responsibilities, first in financial markets, in operational support, then as a business CFO before her appointments in the following decade as CEO of international asset management companies. Sarah also has extensive supervisory board experience including as a member of audit, risk and remuneration committees of supervisory boards, and as chair of an audit committee.

Sarah started her career at Toronto Dominion Australia Limited in Melbourne in 1981. In 1994, she joined ABN AMRO Bank N.V. (ABN AMRO), first in Australia and from 2001 in the Netherlands. At ABN AMRO, she held various positions, such as Chief Financial Officer at the Wholesale Clients Business Unit, and Chief Executive Officer at ABN AMRO Asset Management Holdings N.V.

In August of 2010, she started at Aegon Asset Management as Chief Executive Officer AEGON Asset Management Holding B.V. In August 2016, Sarah became a member of the Managing Board of AEGON N.V., which position she fulfilled until June 2019.

Sarah has also held many ancillary positions over the years. In 2006, she joined Artemis Asset Management Limited in Edinburgh as a (non-executive) member of the board and at Montag & Caldwell, Inc as a (non-executive) member of the board in Atlanta, Georgia. In 2010, she joined Nordea Bank Abp as a non-executive board member, where she is also a member of the Board Audit Committee since 2011 (Chair from 2017 to 2021) and of the Board People and Remuneration Committee (in 2010, and from 2021). In 2013, she joined Transamerica Corporation as a board member, where she was also a member of the Risk Committee. From 2015 up to and including 2019, she held two Supervisory Board positions at, respectively, Nederlandse Investeringsinstelling and La Banque Postale Asset Management. Between May 2017 and June 2019 she was also a member of the board of directors of the American Chamber of Commerce The Hague (Amcham).

Between 2019 and 2021, she joined the Supervisory Boards at the Currency Exchange Fund (where she is also a chair of the Audit Committee), Ostrum Asset Management, APG Group, were she is also member of the Audit and Risk Committee and APG Asset Management, where she is Chair of the Remuneration Committee and member of the Finance Committee.
