- **Skin contact:** Wash exposed skin with sufficient amount of water to remove the material for at least 15 minutes. Remove the contaminated clothing and footwear. In case of skin irritation: Consult a physician. Take this MSDS.
- **Eye contact:** Rinse thoroughly with water for several minutes. Keep your eyelids apart and wash your eyes with plenty of water for at least 15 minutes. If contact lenses are used, remove them, if it is easy and rinse again. If eye irritation persists: Consult a physician. Take this MSDS.
- **Ingestion:** Do not induce vomiting. Wash the victim's mouth with plenty of water. Never give anything by mouth to an unconscious person. If possible, have the victim ingest activated charcoal. If you feel unwell, contact a TOXICOLOGICAL INFORMATION CENTER/or a doctor. Take this MSDS.

Symptoms and effects most important acute or delay: Irritating effect.

Notes to the physician: Treat symptomatically. Treatment must be focused on controlling the patient's symptoms and clinical reactions. After first aid, the treatment of symptoms that reappear will only be necessary.

5. - FIRE FIGHTING MEASURES

Fire: Auto-ignition temperature = 611°C.

Like most organic solids, fire is possible at high temperatures or in contact with an ignition source.

Extinguishing measures: - **Appropriate:** Water spray, chemical powder, foam or carbon dioxide (CO₂).

Not Appropriate: Water jets.

Specific substance hazards: Vapors are heavier than air and can spread along the ground. In the event of strong heating, explosive mixtures may form with air. In the event of fire, flammable gases and dangerous vapors are formed.

Firefighting team protection measures: Self-contained breathing apparatus (SCBA) with positive pressure and complete protective clothing. Product packaging involved in the fire, must be cooled with water fog.

6. - MEASURES OF CONTROL FOR SPILL OR LEAK

Personal precautions, protective equipment and emergency procedures:

- **For the staff that is not part of the emergency services:** Avoid to contact with the product. Do not inhaled the powders.
- **For the staff of the emergency department:** Use personal protective equipment and respiratory protective equipment.

Precaution to the environment: Avoid to spilled product from reaching water courses and sewage system. Do not allow contact with soil, surfaces or groundwater.

Methods and materials for a containment and cleanliness: Clean floors and objects carefully, observing environmental regulations. Collect the product with a clean shovel or other instrument that does not disperse the product. Place the material in appropriate containers and remove them to a safe place. For final destination, proceed according to Section 13 of this MSDS.

7. - HANDLING AND STORAGE

Prevention of worker's exposure:

- Handle in a ventilated area or with a general local ventilation / exhaust system. Avoid formation of vapors / mists. Avoid inhaling the product in case of formation of vapors or mists. Inspect containers for damage or leakage before handling them.

Precautions for safe handling:

- Providing appropriate exhaust ventilation on machines and in places where dust can be generated. Contaminated equipment must be cleaned up immediately with water. Floors, walls and other surfaces must be cleaned regularly. Smoking, eating and drinking is prohibited in the application area. Avoid formation of dust. Avoid contact with incompatible materials. Use personal protective equipment as described in section 8.
